 Ever and the said Samuel Taylor for himself his heirs Executors and Administrators  
 Doth Covenant Promise and Agree to and with him the said Nicholas MacCubbin  
 his heirs and Assigns that the said Samuel Taylor his heirs Executors and Adminis-  
 trators and every of them Shall and will at any time hereafter when thereunto  
 required but at the Cost and Charge in the Law of the said Nicholas MacCubbin his  
 heirs and Assigns to make acknowledge suffer and Execute any Deed or Instrument  
 of Writing as the said Nicholas MacCubbin his heirs and Assigns or his or  
 their Council Learned in the Law shall Reasonably Devise Advise or require  
 for the further and Better assurance surety or sure making of the said Land  
 and Premises unto him the said Nicholas MacCubbin his heirs and Assigns  
 For ever and that he the said Nicholas MacCubbin his heirs and Assigns  
 shall and may at all times hereafter have hold use Occupy Possess and  
 enjoy the said Land and Premises without the let Suit Trouble or Distur-  
 bance of him the said Samuel Taylor or of any other Person or Persons  
 Whatsoever and Lastly that he the said Samuel Taylor his heirs Executors  
 and Administrators and Every of them Shall and will For Ever Warrant  
 and Defend the said Land and Premises with all and Singular the  
 Appurtenances thereunto Belonging unto him the said Nicholas MacCubbin  
 his heirs and Assigns For ever against all manner of Person or Persons  
 Whatsoever
