 thereof from and immediately after the Suffering the same or any other Recovery or Recoveries
 of the said mentioned Promises or any part thereof was meant and intended to be and
 enure and it is hereby declared to be and enure and that the Recoverer the same named and
 his heirs should and shall stand and be seized of and in the Recovered Promises and every
 part and parcel thereof to and for the only proper use and Beliofe of the said John Blagott
 his heirs and Assigns forever and to or for no other use Intent or purpose whatsoever
