This Indenture Tripartite made this twentyfirst day of April in the Year of our Lord One thousand seven hundred and fifty eight Between Daniel Lambden of Queen Anne's County Planter of the first part Thomas Ringgold of the first County Merchant of the second Part and James Pilgrim the third of the Queen Anne's County Attorney at Law of the third Part witnesseth that the said Daniel Lambden for and in consideration of the sum of two hundred and twenty pounds current money of Maryland to him in hand paid by the said Thomas Ringgold at or before the sealing and delivery of these presents the receipt whereof is hereby acknowledged and for the better securing and extinguishing all Estates, Tail and all Recoveries and Remainders thereupon expectant or depending of and in those Lands Tenements and Hereditaments herein after mentioned to the said Daniel Lambden by and with the advice and consent of the said James Pilgrim testified by his being a party to and his sealing and executing these presents hath granted bargained sold aliened released and confirmed and by these presents doth grant bargain sell alien release and confirm unto him the said Thomas Ringgold (in his actual possession now being by virtue of a Bargain and Sale to him therof made by him the said Daniel Lambden bearing date the day next before the Day of the Date of these presents for one whole year commencing from the Day next before the day of the date thereof and by force of the Statute for transforming uses into possession) his houses and Assigns All that Tract or parcell of Plantable Land situated lying and being in Queen Anne's County aforesaid called and known by the name of Hickling Springs Containing two hundred Acres of Land together with all and singular the Edifices Buildings Gardens orchards ways water courses commodities privileges Improvements Emoluments Advantages and Appurtenances whatsoever to the same Tract or Parcell of Land belonging or appertaining in any part thereof And the reversion and Reversionis Remainder and Remands Rents issues and profits thereof and of every
