This Indenture made this twenty seventh Day of April seven teen hundred and Sixty five Between Evan Shelby of Frederick County Gentleman of the one part and Sancelot Jacques and Thomas Johnson junior of the City of Annapolis of the other part Witness that the said Evan Shelby in Compliance with a former Agreement made between him and the said Sancelot Jacques and Thomas Johnson junr and also for and in Consideration of ten Shillings Sterling to him in hand paid by the said Sancelot Jacques and Thomas Johnson Junior the Receipt whereof he doth hereby Acknowledge and thereof and therefrom doth Acquit and discharge the said Sancelot Jacques and Thomas Johnson junr their Heirs Executors Administrators and Assigns and every of them by these Presents both given granted bargained sold aliened released enfeoffed and confirmed And by these Presents Doth give grant bargain sell alien release enfeoff and confirm unto the said Sancelot Jacques and Thomas Johnson Junr all that part of a Tract or parcel of Land lying and being in Frederick County aforesaid called the Rowway on the Mountain of Wales granted and confirmed to him the said Evan Shelby containing in the whole three thousand eight hundred and Sixty Acres of Land which is contained within the following Limits to wit Beginning at the end of fifty two Perches on the two hundred and forty fifth Line of the said whole Tract and running with that and the other Outlines thereof to the end of the two hundred and forty ninth Line of the said whole Tract then with the Line of the Land conveyed by the said Evan Shelby to Samuel Chase untill it intersects the two hundred and fifty sixth Line of the said whole Tract then with that and the other outlines thereof to the end of the two hundred and sixty first Line of the said whole Tract then with the Lines of that part of the said Tract conveyed by the said Evan Shelby to Peter Pinkley unto the end of one hundred and nine perches on the back Line being the longest Line of the same part then by a Line drawn to the end of eighty perches on the two hundred and eightieth Line of the said whole Tract and from thence by a straight Line to the Beginning of the said Part hereby intended to be conveyed containing five hundred and Ninety four Acres more or less Together with all Houses
