of the one part and Aaron Moske of the said County and Province of Maryland Planter of  
the other part Witnesseth that the said Moses Moske for and in Consideration of the Sum of  
Twenty pounds Current Money to him in hand paid or secured to be paid by the said Aaron Moske  
and paid both given granted bargained sold aliened enfeoffed and confirmed and by the said pro-  
-sents Doth give grant bargain sell alien enfeoff and confirm unto him the said Aaron  
Moske his hoirs and Assigns forever All that moiety or one half part of a certain Tract or  
Parcel of Land lying Situate and being in Ann Arundel County aforesaid and heretofore  
surveyed and Patented to a certain Guy Moske by the Name of Guy's Will containing  
one hundred Acres more or less which said moiety or fifty Acres part of the above  
mentioned Tract is now in the Possession of the said Aaron Moske Together with all  
and Singular the buildings and Improvements on the said fifty Acres of Land belonging  
or in any wise Appertaining and all the Estate Right Title Interest Claim Property  
and Demand whatsoever of him the said Moses Moske of in and unto the said fifty Acres  
of Land and every or any part or parcel thereof To have and to hold all and  
Singular the said Promises hereby Bargained sold released and Confirmed or mentioned  
or intended so to be and every part and parcel thereof with their and every of their Appurte-  
-nances unto the said Aaron Moske his hoirs and Assigns To the only proper use and  
-moose of him the said Aaron Moske his hoirs and Assigns forever And the said Moses  
Moske for himself his hoirs and Assigns and every of them Doth covenant promise and  
Agree to and with the said Aaron Moske his hoirs and Assigns and to and with every  
of them by these Presents that he the said Aaron Moske and his hoirs shall and lawfully
