

And at the same time came Ann Mook wife of the said Mose Mook who being privately examined out of the hearing of her husband did Acknowledge that she freely and voluntarily did Relinquish her Rights Power in the said Land without being compell'd thereto by threats of her said husband or for fear of incurring his displeasure

This Indenture made this twenty seventh day of April in the Year of our Lord seven-
teen hundred and Sixty eight Between Thomas Gordon of Prince Georges County in the
Province of Maryland Planter of the one part and Richard Henderson of the same County
Province Merchant of the other part Witnesseth that the said Thomas Gordon for and in
Consideration of the sum of One hundred and Seventy five pounds Thirteen Shillings Current
money to him in hand paid the receipt whereof is hereby Acknowledged hath given
Granted Bargained Sold aliened Released Infeoffed and confirmed and by these
Presents he the said Thomas Gordon for himself and his heirs doth give Grant Bargain
Sell Alien Release Infeoffe and Confirm unto the said Richard Henderson his heirs &
Assigns all the following tracts or parcels of Land in the County aforesaid near the Beaver
Dam Branch and near the main Road from Bladensburgh to Upper Marlbro' Town
all that tract or parcel of Land called Gordons Pasture containing two hundred
twenty and one half Acres more or less also all that tract or parcel of Land being
part of a tract of Land called Doalls Pleasure which part was conveyed to the said
Thomas Gordon by Charles Bowman and Elizabeth Bowman on or about the 25 day
of August 1742 and containing Sixty one Acres more or less also all that tract or parcel
of Land called Basil Warrings doth enlarged which was conveyed to the said Thomas
Gordon by Basil Warring Junior on or about the 29 day of October 1765 containing thirty
two Acres and three quarters of an Acre more or less And also all the Lands of the said
Thomas Gordon lying and being in the Province aforesaid with all the Improvements advantages and
Appurtenances to the Lands aforesaid belonging or deemed to belong or in any wise
Appertaining or deemed to Appertain and the Reversion and Reversions Remainders
Remainders Rents Issues and Profits thereof and all the Estate Right Title Interest use
Trust Property Claim and Demand whatsoever of him the said Thomas Gordon and his heirs
of in and to the same To have and to hold the Lands aforesaid with the Promises unto
the said Richard Henderson his heirs and Assigns To the only proper use and behoof
of the said Richard Henderson his heirs and Assigns and to or for no other use Intention
Purpose whatsoever And the said Thomas Gordon for himself and his heirs doth Covenant
and Agree to and with the said Richard Henderson his heirs and Assigns that he the
said Richard Henderson his heirs and Assigns shall and may at all times hereafter
Quietly and Peaceably Hold Occupy and Possess all the Lands aforesaid with the
