 Increase of those of the said Slaves who are Females To have and to Hold the said  
 Bargained and sold three Tracts of Land and part of the a<sup>d</sup> other Tract of Land with their  
 and each and every of their Rights Members and Appurtenances to him the said John Buchanan  
 his Heirs and Assigns to the only proper Use and Schoole of him the said John Buchanan his  
 Heirs and Assigns forever and to or for no other Use Intent or purpose whatsoever And to  
 have and to hold the said Negro Slaves by the Increase a<sup>d</sup> to him the said John  
 Buchanan his Executors Adms and Assigns as his and their own proper Slaves to his (their  
 own proper use provided Always and these presents are upon this exp<sup>re</sup>s condition that if  
 the said John Hammond Dorsey his Heirs Executors or Administrators do and shall well and  
 truly pay or cause to be paid to him the said John Buchanan his Heirs Executors Administrators  
 Assigns the said Sum of two thousand and xx Seventeen Pounds five Shillings and eleven  
 pence Sterling abov before the Ninth Day of August next then these Presents and every Article  
 (Clause)
