the said Henry Ridgely his Heirs Executors and Administrators and every
of them by these Presents Hath given granted bargained Sold Aliened
Released and confirmed and by these Presents Both give grant bargain
Sell Alien Release and confirm unto him the said Henry Ridgely his
Heirs and Assigns forever all that part of a Tract or Parcel of Land con-
-taining One hundred and fifty four Acres of Land more or less lying
in Ann Arundel County aforesaid which was heretofore on or about the
Ninth Day of August Seventeen hundred and Sixty three Sold and
conveyed by Richard Warfield to him the said Edward Hall and which
same One hundred and fifty four Acres are part of a Tract of Land called
