 Parcels and Parts or Tracts or Parcels of Land in the said Recited
 Deed of Mortgage Mentioned also the said Tract of Land called
 Cheney Hill and also the said Part of the Tract of Land aforesaid called
 the Resurvey on Ridgway's Farm and likewise all Other Tracts pieces
 or Parcels of Land whereof the aforesaid Benjamin Welsh died Seized
 Together with all Buildings Gardens Orchards Woods Ways Waters
