This Indenture made this twenty third Day of May in the Year of our Lord One thousand seven hundred and sixty nine between Basil Williams of Frederick County Planter of the one part and Henry Ridgely of Ann Arundel County Gentleman of the Other Part Witnesseth that the said Basil Williams for and in consideration of the sum of one hundred and sixty three Pounds current Money by him the said Henry Ridgely to him the said Basil Williams in Hand paid at and before the Sealing and Delivery of these presents the Receipt whereof he doth hereby Acknowledge and him the said Henry Ridgely of every Part thereof doth acquit exonerate and discharge hath granted bargained & sold & by these Presents doth grant bargain and sell unto the said Henry Ridgely his Executors Administrators & Assigns one hundred and fifty Acres of Land lying on the West End of a Tract of Land called Basils Choices in Frederick County with the Appurtenances to have and to hold the said one hundred and fifty Acres of Land with the Appurtenances therunto belonging unto the said Henry Ridgely his Executors Administrators & Assigns Provided always that if the said Basil Williams shall pay or cause to be paid unto the said Henry Ridgely his Executors Administrators or Assigns the full sum of one hundred & sixty three Pounds current Money with legal Interest for the same from the Date of these presents on the first Day of October next that then this present Writing shall be utterly void and frustrate and the said Basil Williams for himself his Executors Administrators & Assigns
