This Indenture made this eighteenth Day of October in the year Seventeen hundred & Sixty nine Between John Rogers of Prince Georges County of the one part and William Nelson of Charles County Planter of the other Part Whereas for docking hawing and Extinguishing all Estates tail & reversions or remainders thereupon Expectant or Depending of and in the lands and Appurtenances herein after mentioned the said John Rogers as Demandant did heretofore (at the request Cost and Charges of the said William Nelson) prosecute and sue forth out of his Lordships high Court of Chancery
