 Whereas for the Docket barring and extinguishing all Estates held and Reversion or Remainders
 thereupon expectant or depending of and in the Lands and Appurtenances herein after mentioned the said
 John Rogers as Demandant did heretofore at the Request post and charge of the aforesaid Robert
 Lawson prosecute and sue forth out of his Lordships High Court of Chancery his said Lordships writ
 of Entry and Desceis in extenst against him the said Robert Lawson returnable and Returned to the Provincial
 Court at Annapolis the Third Tuesday of October instant whereby the said John Rogers did
 demand against him the said Robert Lawson all that Tract or parcel of Plantable Land called
 The Argyle lying and being in Charles County aforesaid and Containing One hundred Fifty
 Six Acres of Land to which said writ the said Robert Lawson did appear in his proper person and
 Nouch to Warrenty thereof the Common Voucher of the same Court and such further and
 other Proceedings were thereupon had that the said John Rogers did by Judgment of the same
 Court Recover his seisin against the said Robert Lawson of and in the Demanded premises
 and the said Robert Lawson did recover over in Value against the said Maximilian
 Mathews and the said Maximilian Mathews did recover over in Value against the Common
 Voucher whereby a common Recovery of the aforesaid premises hath been had and suffered Now
 This Indenture Witnesseth That for the settling and Declaring the intent and use of the
 said Recovery and for and in Consideration of Five Shillings current Money by him the said
 Robert Lawson to the aforesaid Maximilian Mathews in hand paid thereceipt whereof hereby
 Acknowledged It is hereby Covenanted granted agreed and Declared by and between the said
 Parties to these presents that the said Common Recovery soe aforesaid in any other manner
 had and suffered and the Execution thereof from and immediately after the suffering the same
 or any other Recovery or recoveries of the said mentioned premises or any part thereof was meant and
 intended to be and ever and it is hereby Declared to be and Ever and that the Recoverer therein
 therein named and his heirs should and shall stand and be seized of and the recovered premises
 and every part and parcel thereof to and for the only Proprietary and behoof of the said
 Robert Lawson his heirs and assigns forever and to or for no other use intent or purpose
 whatsoever In witness whereof the Parties to these presents have hereunto interchangeably with their
 hands affixed their Seals the Day and year first above written
