This Indenture made this thirteenth Day of November in the Year of our Lord one Thousand seven hundred and Sixty nine Between Thomas Snowden and Samuel Snowden of Prince Georges County in the Province of Maryland Iron Masters and John Snowden of Anne Arundel County and Province aforesaid Iron Master of the one part and John Aldridge of Frederick County in the said Province Planter of the other part Witnesseth that the said Thomas Samuel & John Snowden for and in consideration of the sum of Eighteen Pounds fifteen Shillings Sterling money to them in hand paid together with the costs of a Rowway by the said John Aldridge on or before the sealing and Delivery hereof the receipt thereof having Acknowledged and thereof do Acquit release and forever discharge the said John Aldridge his heirs and assigns and for diverse other good causes and Considerations have granted bargained sold aliened and confirmed and by these presents do grant bargain sell alien & Confirm unto the said John Aldridge his heirs and assigns forever Part of a tract of Land called Moores Post being seventy five Acres of the said Tract Together with the residue thereof being one hundred and fifty Acres Addeed Beginning at a bounded white Oak being (the)
