This Indenture made this thirty first day of March in the Year of our Lord one Thousand seven hundred and Seventy Between John Dorsey of Ann Arundell County Merchant of the one part and John Glover of Baltimore County Planter of the other part Witnesseth that he the said John Dorsey for and in consideration of the sum of Sixty two Pounds ten Shillings Currant Money to him in hand paid or secured to be paid by the said John Dorsey at or before the Ensealing and Delivery of these Presents the receipt whereof the said John Dorsey doth hereby Acknowledge and hereof doth acquit Converte and fully discharge the said John Glover his Heirs and Assigns for ever Hath given granted Bargained and Sold and by these Presents do give grant bargain Sell Alienate Infeof and confirm unto him the said John Glover his Heirs and Assigns for ever all that part or parcel of Land being part of Tract of Land called and known by the Name of John Mistake lying in Baullimore County Begining for the said Barall of Land at the Begining Place where the Originall Tract Begins at and running thence with the Lines of the Originall Survey Viz North Twenty degrees East Sixty Perches then North (seventy)
