 other Deeds and Incumbrances whatsoever and lastly that he the said
 John Dorsey doth further Covenant promise and Agree for himself his Heirs
 Exec^ts Adm^rs to and with the said John Glover his Heirs and Assigns
 that he the said John Dorsey his Exec^ts and Adm^rs shall and will from
 time to time and all times hereafter at the reasonable request of the said
 John Glover his Heirs and Assigns make such further and other Grant
 and Assurance for the more sure making and confirming the said Land
 and Premises unto the said John Glover his Heirs and Assigns forever according
 to the true Intent and meaning hereof as he or they by his counsell Learned in
 the Law reasonably devised Advised or required In Witness whereof the said
