 Land and containing as above said be the same more or less Together with all  
 and singular the Houses out Houses Barns Buildings Stables Mills Mill  
 Houses Mill Dams Sluices Waters Races Banks Mill Tails Meadows  
 Gardens Orchards Fences Marshes Ways Waters Water courses Woods  
 Underwoods Timber and Trees Mines Minerals Quarries Rights Liberties
