This Indenture made the Sixteenth Day of August in the Year of our Lord one  
 thousand seven hundred & sixty six between William Strachan of London Town in the  
 County of Am Arundel of the one Part and Anthony Stewart of the City of Annapolis Mer-  
 chant of the other Part Whereas by Indentures bearing Date on or about the Third  
 Day of January last past Between a certain James Dick of the one Part and the said  
 William Strachan of the other Part the said James Dick as Surviving Executor of the last  
 will and Testament of the said William Pele late of Am Arundel County deceased and  
 under the power and Authority and in virtue of the last will and Testament of the  
 said William Pele did Grant Bargain Sell Alien release and confirm unto the said  
 William Strachan for the Consideration therein mentioned a Tract of Land called Symmonds  
 Stones containing one hundred & fifty three Acres more or less Situate lying and being  
 in the County aforesaid near Huntington also one other Tract of Land called Patchers  
 Choice containing one hundred Acres more or less situate lying and being in the County  
 aforesaid on the South side of the main Falls of Patuxent River To have and to Hold  
 the said Tracts of Land unto the said William Strachan his Heirs and Assigns forever  
 as by the said recited Deeds recorded in the Provincial Court and records reference  
 being there to had may more fully & at large appear Now this Indenture Witnesseth that  
 the said William Strachan for and in Consideration of the sum of fifty Pounds Current  
 Money to him in hand paid by the said Anthony Stewart the Receipt whereof he doth hereby  
 Acknowledge & thereof doth acquit and discharge the said Anthony Stewart his Heirs  
 Executors Administrators and Assigns and every of them by these presents both given  
 granted bargained sold aliened released enfeoffed and confirmed and by these  
 presents doth grant bargain sell alien release in feoff & confirm unto the said  
 Anthony Stewart his Heirs & Assigns forever all the aforesaid Tracts or parcels  
 of Land lying and being in the County aforesaid together with all Houses Buildings  
 Gardens Ways Orchards Woods Underwoods waters water Courses Improvements  
 Advantages Privileges & appurtenances whatsoever to the said Tracts of Land  
 belonging or in any wise appertaining And all the Estate Right Title Interest  
 Use Inhab possession Claim and demand whatsoever of him the said William  
 Strachan of in & unto the Tracts of Land aforesaid and premises with the appurtenances
