Debt as also y sum of two hundred & twenty nine pounds of Sol. cost of suit & y said John in money

Command was given to y Sher<sup>r</sup> of Kent County 25. day of June Anno Dom. 1700 that he Elizabeth Mounifor alias vidua Elly. Mounifor Ex<sup>r</sup> of last will & Testament of Timothy Mounifor late of said County Blunder Doe. if found in her bailiwick & her said keep soe that he have her body before our Justices w<sup>ch</sup> he shal be hold for said County to answer unto So. ltho Norroagh Charles Wright Katherine his wife Ex<sup>r</sup> of last will & Testament of Robert Norroagh late of said County Carpenter D<sup>r</sup> of a plea that she owes unto them y full sum of four hundred pounds of good Sounes more or less & Casque which from them she unjustly Detaineth &c.

The which cause standing for try that y said Defendant cometh and answer to y said action who being came not neither by herself nor atty but made default wherefore Judgment was awarded to y said Plaintiff for y sum of four hundred pounds of Sol. Debt & cost of suit
