 command was given to the Sheriff of Kent County on 25 Day of June anno Domini 1701 that he
 attach any of the goods chattels Debt rights etc. of Hannah Tofort if they should be found in
 his bailiwick to the value of one pound sixpence of Pennsylvania Money (five
 hundred fifty nine pounds of T. C. to satisfy unto Richard Torum a certain Debt
 cost recovered against her that by good and full men of of his Bailiwick he make
 known to the Court that he or they be personally appeared at the next Court to show
 cause why the same should not be returned Non est. in bonis
 The said cause was continued until the present Court
 and now here at this Day viz. 23 Day of Sept. anno Domini 1701 came Elias
 King high Sheriff of Kent County in answer thereto of this Endorsed writ
 Attached in the hands of Patrick Fragh one pound sixpence Pennsylvania
 money as also the sum of five hundred fifty nine pounds of T. C. cost
 also made known before John Blackett Charles Dollinworth that he be
 appeared to do as by the writ with Jam. Comings Elias King Sheriff
 to shew why said Hannah Tofort neither by her self nor attorney appearing to show
 cause why the same should not be condemned for satisfaction of the Debt cost
 The Plaintiff by Richard Macklin his attorney in law sheweth that the same should
 be condemned which was granted him by the Court
 Therefore it is considered by the Court here that the Plaintiff Richard Torum have
 execution of the said Hannah Tofort as well for the sum of one pound sixpence
 Thilling Debt Pennsylvania money as also the sum of five hundred fifty nine
