 Instance and Request of him the Said James Shofwood doth & doth lawfully and by the Said James
 Shofwood doth & doth lawfully by an Act thereof to this Court annexed
 into Court brought the Said James's apparatus amounting in value to the sum of 90^s 8^d in
 consideration whereof the Said James upon himself assumed unto the Said Giles Bond then and
 there faithfully promised that he the Said James when the same after wards required by the
 sum of 90^s 8^d well truly he would pay yet notwithstanding the Said James his
 assumption before made notwithstanding nor regarding but plotting contriving & craftily
 resigning the Said sum of 90^s 8^d craftily & subtilly to be used & profaned by the Said James
 of 90^s of 8^d unto the Said Giles Bond he hath not paid altho' often demanded but the Said
 pay hath done & refused still doth deny & refuse unjustly obtained to the damage of
