The which cause being continued from Court until this present Court. said Sarah Soas & claimt by Richard Macklin her att^y & y^e said Defendant Barbara Collins neither by her self nor attorney appearing Judgom^t is awarded that y^e said Summe of God. should be condemned for satisfaction off

Salsnam who was Esq. of Richard Salsnam late of Salbath County Inholder Dor. if he should be found in his bailiwick to attach & personally appear before his May^{ty} Justices at y^e next Court to show cause if any he have cause Execution should not issue at him for y^e Summe of 1300. hundred & Tenn pounds of God. a certaine Non-suitt recovered against y^e said Richard Salsnam in his lifetime by Cap^t John Hawkins at a Court held for Salbath County y^e Nineteenth Day of June Anno Domⁱ 1694

Day Anno Domⁱ 1700 that y^e said Defendant Elias King Esq. of E. of S. Salsnam who was late of Salbath County Dor. in his said ffauas doo receive from y^e said Richard Salsnam a Summe of fifty pounds of God. for a Non-suitt as also y^e Summe of one hundred & twenty one pounds of God. Cost of Suit according to Act. of asembly in that behalf made & provided y^e said Summe in money In Dowdall
