Command was given to the Just. of Kent County 29 day of March Anno Dom. 1701 that  
he take Isaac Faulk of Kent County Inhabitor if found in his Bailiwick & him safe-  
keep & so that he be not taken, body & goods of our Justice at the next Court. to be held for said  
County to answer unto Edward Bathurst of a plea of Trespass upon the Case &c  
at which next Court viz. 24 day of June Anno Dom. 1701 the day of the  
return of said Writ came Elias King high Just. of said County & made  
return thereof thus Endorsed viz. Copy of me Elias King Just.

on which said day the said Defendant by Michael Marklin his atty appears and prays  
thereof to be imparled untill the next Court which was granted by said day was given by  
Blairt also and Marklin p. q.

The which cause was continued from Court to Court untill this present Court and now  
here at this day viz. 28 day of Novem. Anno Dom. 1701 came at well the said Def.  
by his said atty & also the said Blairt by his said atty and the said Cause standing  
for Exall the said Blairt &c

Kent s. Isaac Faulk of Kent County Inhabitor stands attached to answer unto Edward  
Bathurst of a plea of Trespass upon the Case &c

And whereupon the said Edward Bathurst by Richard Marklin his attorney  
complains that whereas the said Edward Bathurst from the eighth of the  
Anno Dom. 1699. untill the four twentieth day of April in the year last at Kent  
County within the Jurisdiction of this Court at the Instance & request of the said Isaac  
Faulk had sold and delivered unto the said Isaac Faulk divers goods wares & Merchants  
amounting in the whole to the sum of three hundred ninety six pounds of good pay  
at the Instance and request of the said Isaac Faulk the said 24 day of April Anno  
Dom. 1699. at Kent County the said Isaac Faulk had paid unto a certain Thomas Howell by word  
and for the use of him the said Isaac Faulk the sum of two thousand and one pound of good  
goods wares & Merchants sold & delivered and the said Isaac Faulk as a part amount in the  
whole to the sum of two thousand four hundred ninety six pounds of good. at the  
an act thereof to this Court. anno 1700. hereunto first brought by said defendant  
In consideration whereof the said Isaac Faulk upon himself assumed and unto the said  
Edward Bathurst then & there faithfully promised that he the said Isaac Faulk would  
sum of 2996 of good. when thereunto afterwards required he would well & truly  
content & pay and altho the said Isaac Faulk had paid & satisfied unto the said Edward  
Bathurst the sum of seven hundred eighty one pound of good. yet as to the  
residue thereof being one thousand seven hundred and seven pounds of good the  
said Isaac Faulk his promise and assumption aff. little regarding but plotting contriving  
fraudulently intending him by the said Edward Bathurst in that behalf craftily &  
subtly to deceive & defraud the said sum of 2996 of good into the said Edward Bathurst  
he hath not paid altho thereunto often required but to pay he hath long & refused &  
still doth deny & refuse & unjustly obtained long damages of the said Edward Bathurst  
three thousand four hundred and fourteen pounds of good. and thereupon he brings  
this Suit
