Command was given to the Sheriff of Kent County by 29 day of August annoz Dom^t. 1700 That he attacham^t to goods chattels & other effects of Anthony Barley if found in his baileys to the value of one thousand two hundred forty four pounds of Tsd. to satisfye unto Mr. Galler a certaine debt of Tsd. according to a Judg^mt recovered against him before his Maj^y and Justices at a Court held for said County by 28 day of August annoz Dom^t. 1700 of which he is tenuit and wher^t same had attacheado any part therof to him in his lastyng keep so that he haue & haud before thair justis^t Justitally^t his Court likewise make knowne he is party or partie in whose hands same shold be attacheado so that his sherrif^t to appear al^t M^r Court to shew cause^t ther^t At which he^t Court b^t 26. Day of Novem^r annoz Dom^t. 1700 by Day of Returne of said writt^t and Eliz^t King high Sheriff of said County made returne of said writt^t ther^t endorsed b^t a man attacheado a man of the Estates of Anthony Barley and Eliz^t King Sheriff
