1701 James Thistlewood of Dorchester County planter if found in his bailiwick & him safe keep. soe that he shal  
his body before his Majestys Justices at next Court to be hold for Said County to answer  
unto Stephen Austin of a plea of Trespas upon Case  
Att which next Court viz. 23. day of Sep. Anno Dom. 1701 day of 2. term of  
Said Court came Elias King high Thert. of Said County & made returns thereof viz.  
Cp in corpus Elias King Tert

The which cause being cont. untill 2. day of Novem. Anno Dom. 1701  
came ad as well Said plaint by Michael Parle his atty. ad also Said Defend. by  
Richard Macklin his atty. and Said cause standing for tryall, plaint Doct. &  
Kent. County in Maryland vs James Thistlewood late of Dorchester County planter stands  
ad attached to answer unto Stephen Austin of a plea of Trespas upon Case

And whereupon Said Stephen by Michael Parle his atty. complaineth & saith that whereas  
Said James on 30. day of Feb. Anno Dom. 1699 and at divers times afterwards  
continuing untill 20. day of May Anno Dom. 1700 in Dorchester County aff. within  
Jurisdiction of this Court at 1. instand and request of Said James had sold & delivered  
unto him Said James by Said Stephen divers wares goods & Merchandises & also at 2. take  
Instand and request within & hind aff. within Jurisdiction aff. Said Stephen paid  
unto a forlaint John Manatt for & proper use of him Said James Sum of fifty pounds  
of Tod. all which goods wares & Merchandises sold & delivered and Tod. paid amounteth in  
whole to Sum of 100 thousand one hundred & only eight pounds of Tod. as an Act.  
he saith annexed & here in Court brought & James appears In consideration whereof  
Said James upon his oaths & affirm. unto Said Stephen faithfully promised that he  
Said James by aff. Sum of Two thousand one hundred & only eight pounds of Tod. and  
by aff. Said Stephen he would well & truly pay when the same afterwards required yet  
nevertheless Said James by aff. Sum of 2120. Tod. according to his promise & assumption  
unto Said Stephen he did not pay altho often demanded but Said James to pay he hath denyed &  
refused and still doth deny and refuse & unjustly detain to Said Stephen  
four thousand pounds of Tod. and thereupon he brings this Suit ad In Doe
