Counes of God. unto y^e Said Edward altho offlen demanded he hath not paid but y^e same to pay hath and still doth deny & refuse to y^e Damages of y^e Said Edw. eight hundred pounds of God. and thereupon he brings this Suit Marklin & y^e

But y^e Said Plaintiff by his Said Att^y prayd that y^e Said Defendant Dan Soas might come into Court. and make answer to his Said Debt. who neither in his proper person nor by his Att^y appearing Judgm^t. is awarded to y^e Said Plaintiff for y^e Said Sum of four hundred pounds of God. cost of Suits

Therefore it is considered by y^e Court that y^e Said Plaintiff Edw. Fry do recover from y^e Said Defendant Dan Soas as well y^e Sum of four hundred pounds of God. Debt as also y^e Sum of five hundred & thirty pounds of God. cost of Suits and y^e Said Dan Soas in Morye

Command was given to y^e Sher^t. of Kent County y^e 24 day of Sep^r. Anno Domⁱ. 1700 that he take Dan Soas alias Dulus Dan Soas of Kent County Gent. if found in his bailiwick and him safe keep so that he have his good before our Justice at y^e next Court to be hold for our Said County to answer unto Edw. Fry of a plea of Debt. At which next Court viz^t. y^e 26. day of Novem^r. Anno Domⁱ. 1700 y^e day of y^e return of y^e writt came Elias King high Sher^t. of Said County and made return thereof in these words viz^t. Non. East Inventus / Elias King Sher^t.

Command was likewise given to y^e Said Sher^t. of Kent County y^e 29. day of Novem^r. Anno Domⁱ. 1700 that he take Dan Soas alias Dulus Dan Soas of Said County Gent. if found in his bailiwick and him safe keep so that he have his good before our Justice at y^e next Court to be hold for Said County to answer unto Edw. Fry of a plea of Debt. At which next Court being an adjourned Court all causes were cont^d and all process were cont^d. in y^e Sher^t's custody untill y^e next Court.

At which next Court viz^t. y^e 13. day of February y^e Day of y^e return of Said writt according to adjournm^t. came Elias King high Sher^t. of Said County and made return thereof in these words viz^t. Capi corpa off Elias King Sher^t.

On which Said day y^e Said Defend^t. Dan Soas appeared in his proper person and prayd thereof to imparle untill y^e next Court which was granted unto him y^e Sum day was given y^e Plaintiff also Marklin & y^e

And now here at this day viz^t. y^e 29. day of March 1701 came y^e Said Plaintiff by y^e Marklin his Att^y and y^e Said Cause standing for finally y^e Plaintiff Debt in Maryland - 2 s^d. Dan Soas alias Dulus Dan Soas of Kent County Gent. was summoned to answer unto Edw. Fry of a plea that he render him y^e full Sum of one

Thousand one hundred thirty eight pounds of good Sound Merchantable beafe safe God. and Casque when to him he oweth from him he any thing shal^d And whereupon y^e Said Edward Fry by Richard Marklin his Att^y sayd that Whereas y^e Dan Soas at Kent County within y^e Jurisdiction of this Court y^e first day of May Anno Domⁱ. 1700 by his
