Comptroller of the treasury, one of whom shall be known as special assistant attorney general of the State Roads Commission and the other of whom shall be known as special attorney for the State Accident Fund. Attorney General is also authorized to appoint such additional assistants, special attorneys and law clerks as may from time to time be authorized in the budget.] MAY APPOINT SUCH DEPUTY ATTORNEYS GENERAL, ATTORNEYS, ASSISTANTS AND LAW CLERKS AS MAY BE AUTHORIZED FROM TIME TO TIME IN THE BUDGET. The deputy fattorney ] ATTORNEYS general, [and all] assistant [and special assistant] attorneys general and special attorneys shall be practicing lawyers of the State of Maryland in good standing, each of whom shall hold his respective office during the pleasure of the Attorney General and each of whom shall receive such salary as [shall be] provided in the State budget. [All of the salaries above provided shall be payable monthly. The salaries of the special attorneys of the Department assigned to the following agencies: The State Roads Commission: the Property Acquisition Division of the Department of Public Improvements: the Subsequent Injury Fund; the State Accident Fund; and the Department of Employment Security shall be payable from the funds of the agency to which the special attorneys are assigned as provided for in the annual State budget and these attorneys may be located in the offices of the agency to which they are assigned. 1 The salaries of all DEPUTY ATTORNEYS GENERAL, assistant attorneys general and all [other] special attorneys [than those assigned to the State Roads Commission, the Property Acquisition Division of the Department of Public Improvements; the Subsequent Injury Fund, the State Accident Fund and the Department of Employment Security, shall be] ARE payable from the funds of the Department of Law unless otherwise provided in the annual State budget [and the offices of these assistants and other special attorneys shall in the discretion of the Attorney General be located in the offices of the Department of Lawl. The deputy [attorney] ATTORNEYS general, [and] the assistant [and special assistant] attorneys general, THE SPECIAL ATTORNEYS, and the law clerks shall each perform such duties as the Attorney General may from time to time assign to them, and the Attorney General [is hereby authorized to] MAY assign to them and each of them the performance, subject to his discretion and control, of any of the duties required of him by law. [Provided, however, that from and after the time the Attorney elected in the November election of 1958 General commences his term, the said Attorney General shall receive a salary of fifteen thousand dollars (\$15,000.00) per annum. Provided further, that from and after the time the Attorney General elected in the November election of 1966 commences his term, the said Attorney General shall receive a salary of twenty thousand (\$20,000.00) dollars per annum. Provided, further, that from and after the time the Attorney General elected in the November election of 1970 commences his term, the said ] THE Attorney General shall receive such annual
