SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That new Section 9M be and it is hereby added to Article 64A — Merit System, of the Annotated Code of Maryland (1972 Replacement Volume and 1975 Supplement) to read as follows:

Article 64A - Merit System

OF THE DATE OF TRANSFER OF TITLE TO THE LAND AND IMPROVEMENTS COMPRISING GLENN L. MARTIN STATE AIRPORT TO THE STATE OF MARYLAND, ALL FULL-TIME EMPLOYEES OF [[THE GLENN L. MARTIN STATE AIRPORT WHO HAVE BEEN FOR A PERIOD OF SIX MONTHS OR MORE IMMEDIATELY PRECEDING THE TRANSFER OF TITLE, REGULARLY EMPLOYED BY THE AIRPORT SHALL BE TRANSFERRED WITH NO DIMINUTION OF SALARY TO THE EMPLOYMENT OF THE STATE OF MARYLAND, WITH FULL CREDIT FOR ALL PURPOSES FOR PRIOR YEARS SERVICE WITH THE GLENN L. MARTIN AIRPORT AND THE STATE OF MARYLAND AND WITH NO REDUCTION IN RETIREMENT OR OTHER BENEFITS OR ALLOWANCES EARNED AND ACCRUED BY SUCH EMPLOYEE THROUGH PRIOR STATE SERVICE, NOTWITHSTANDING THE PROVISIONS OF SECTION 53 OF ARTICLE 88B OF THE ANNOTATED CODE OF MARYLAND, WITHOUT FURTHER EXAMINATION OR QUALIFICATION AND SHALL BE SUBJECT GENERALLY TO THE PROVISIONS OF ARTICLE 64A OF THE ANNOTATED CODE OF MARYLAND PROVIDED FURTHER, THAT ANY AGREEMENTS BETWEEN GLENN L. MARTIN AIRPORT AND ANY LABOR GROUP REPRESENTATIVE OF EMPLOYEES AT THE AIRPORT WHICH IS IN EXISTENCE AT THE TIME OF THE TRANSFER OF TITLE TO THE STATE OF MARYLAND SHALL BECOME THE OBLIGATION OF THE STATE OF MARYLAND.]] CHESAPEAKE PARK, INC. WHO WERE SUBSEQUENTLY ASSIGNED TO WORK AT THE GLENN L. MARTIN STATE AIRPORT ON FITHER A FULL-TIME OR REGULARLY SCHEDULED PART-TIME BASIS SHALL BE CONSIDERED FOR PURPOSES OF THIS SECTION AS PROMOTIONAL CANDIDATES FOR EMPLOYMENT WITH THE STATE AVIATION ADMINISTRATION IN ACCORDANCE WITH SECTION 18 (E) OF THIS ARTICLE.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1976.
