- THE BOARD OF COUNTY COMMISSIONERS OF ALLEGANY COUNTY SHALL LEVY AND COLLECT FROM THE PROPERTY OWNERS AT THE TIME OF THE COUNTY TAX LEVY FOR THE YEAR 1977, OR ANY SUCCEEDING YEAR, WITHIN THE DESCRIBED AREA OF "CRESAPTOWN SPECIAL TAXING AREA OR DISTRICT" AS CREATED BY CHAPTER 169 OF THE ACTS OF THE LEGISLATURE OF 1939, THOSE AMOUNTS NOT EXCEEDING 30 CENTS ON EACH \$100 WORTH OF ASSESSABLE PROPERTY IN THE "CRESAPTOWN SPECIAL TAXING AREA OR DISTRICT," ALLEGANY COUNTY, MARYLAND, AS MAY BE REQUESTED BY THE DULY CONSTITUTED MEMBERS OF THE CRESAPTOWN CIVIC IMPROVEMENT ASSOCIATION. THOSE TAXES SHALL BE COLLECTED IN THE SAME MANNER AS IS PROVIDED BY SECTION 1 OF CHAPTER 169 OF THE ACTS OF 1949 OF THE PUBLIC LOCAL LAWS OF MARYLAND AND SHALL BE COLLECTED IN ADDITION TO THE TAXES AUTHORIZED TO BE LEVIED AND COLLECTED BY THAT ACT AND SHALL BE PAID OVER BY THE BOARD OF COUNTY COMMISSIONERS TO THE CRESAPTOWN CIVIC IMPROVEMENT ASSOCIATION, A CORPORATION.
- (B) THE TAXES COLLECTED UNDER THE PROVISIONS OF THIS SECTION SHALL BE USED BY THE CRESAPTOWN CIVIC IMPROVEMENT ASSOCIATION, A CORPORATION, TO FURNISH STREET LIGHTS IN THE "CRESAPTOWN SPECIAL TAXING AREA OR DISTRICT."
- (C) ANY MONEYS, FROM WHATEVER SOURCE DERIVED, HELD BY THE CIVIC ASSOCIATION AFTER MAKING PROVISIONS FOR LIGHTS MAY BE EXPENDED FOR:
- (1) THE CONSTRUCTION AND MAINTENANCE OF COMMUNITY PLAYGROUNDS AND OTHER RECREATIONAL AND PLAY AREAS: AND
- (2) THE PROVISION FOR OTHER COMMUNITY PROJECTS AND SERVICES AS NEEDED OR DESIRED BY THE CITIZENS OF THE CRESAPTOWN TAX AREA.
- (3) THE EXPENDITURE OF ANY SURPLUS PUNDS HELD BY THE CIVIC ASSOCIATION FOR THE SPECIAL TAX AREA SHALL BE MADE ONLY AFTER DUE CONSIDERATION BY THE ASSOCIATION AND UPON A MAJORITY VOTE OF THE ASSOCIATION.
- (D) THE CIVIC ASSOCIATION MAY EMPLOY AN ACCOUNTANT TO AUDIT ITS BOOKS AND ACCOUNTS AND MAY ALSO EMPLOY WHATEVER LEGAL COUNSEL IT CONSIDERS NECESSARY. THE CIVIC ASSOCIATION SHALL ALWAYS KEEP AVAILABLE AND OPEN TO PUBLIC INSPECTION BY RESIDENTS OF THE CRESAPTOWN TAXING AREA, ITS BOOKS AND ACCOUNTS.

THE CRESAPTOWN CIVIC IMPROVEMENT ASSOCIATION, A CORPORATION, MAY PROVIDE, BY CONTRACT OR OTHERWISE, FOR THOSE FACILITIES PERMITTED BY SUBSECTION 116A(C) OF THIS CODE IN "CRESAPTOWN SPECIAL TAXING AREA OR DISTRICT," AND TO PAY FOR THOSE FACILITIES OUT OF THE TAXES LEVIED AS
