- THE MONTGOMERY COUNTY DEPARTMENT OF CORRECTION (H) REHABILITATION SHALL DETERMINE IF THE PAROLEE OR AND PROBATIONER MEETS THE ELIGIBILITY CRITERIA PARTICIPATION IN THE PROGRAM AND IF THE PAROLEE OF PROBATIONER IS A RESIDENT OF MONTGOMERY COUNTY, AND MAY ADMIT ONLY ELIGIBLE RESIDENTS TO THE PROGRAM. THE LENGTH OF THE PAROLEE'S OR PROBATIONER'S PARTICIPATION IN THE PROGRAM MAY NOT EXCEED SIX MONTHS. THE PAROLEE OR PROBATIONER IS SUBJECT TO THE RULES, REGULATIONS AND GUIDELINES OF THE PRERELEASE CENTER. IF THE COUNTY DEPARTMENT OF CORRECTION AND REHABILITATION DETERMINES THAT THE PAROLEE OR PROBATIONER SHOULD BE WITHDRAWN FROM THE PRERELEASE CENTER BECAUSE OF IMPROPER CONDUCT OR OTHER APPROPRIATE REASONS, THE COUNTY DEPARTMENT OF CORRECTION AND REHABILITATION SHALL RELEASE THE PAROLEE OR PROBATIONER TO THE PAROLE OR PROBATION AGENT AND PROVIDE A REPORT TO THE AGENT OF THE INDIVIDUAL'S PERFORMANCE AND CONDUCT WHILE AT THE CENTER.
- (I) MONTGOMERY COUNTY MAY CONTRACT ANNUALLY WITH FEDERAL AND STATE ADULT PAROLE AND PROBATION AUTHORITIES FOR THE REIMBURSEMENT ON A PER DIEM BASIS FOR OPERATIONAL COSTS TO MONTGOMERY CCUNTY FOR PROVIDING COMMUNITY CORRECTIONAL SERVICES AS PROVIDED IN THIS SECTION.]

SECTION [[3]] 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1976.

CHAPTER 834

(House Bill 1872)

AN ACT concerning

Creation of a State Debt - Loyola College Science Center

FOR the purpose of authorizing the creation of a State Debt in the amount of [[\$3,700,000]] \$1,850,000, the proceeds to be used for the construction of a science building on the campus of Loyola College, Baltimore, Maryland, subject to the requirement that Loyola College shall obtain from public or private sources a sum up to \$1,850,000 as an equal and matching fund for the same purpose; and providing generally for the issue and sale of bonds evidencing such loan.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That:
