

POSITIONS TO BE CREATED SHALL BE APPROVED BY THE COUNTY COMMISSIONERS, BUT THE APPOINTMENT OF A PERSON SHALL BE SUBJECT TO THE APPROVAL OF THE ECONOMIC DEVELOPMENT COMMISSION.

(G) ANNUAL REPORTS SHALL BE FILED WITH THE BOARD OF COUNTY COMMISSIONERS OF FREDERICK COUNTY AND MADE AVAILABLE TO THE PUBLIC. THE ANNUAL REPORT SHALL INCLUDE SUBJECTS AND RECOMMENDATIONS FOR THE IMPROVEMENT AND ADVANCEMENT OF THE ECONOMIC WELFARE OF THE PEOPLE OF FREDERICK COUNTY. ]]

(B) AN ORDINANCE OR RESOLUTION CREATING AN ECONOMIC DEVELOPMENT COMMISSION SHALL INCLUDE THE FOLLOWING PROVISIONS:

(1) THAT THE COMMISSION SHALL CONSIST OF BETWEEN NINE AND 15 MEMBERS, WHO SHALL BE APPOINTED BY THE BOARD OF COUNTY COMMISSIONERS; AND THAT THE MEMBERS SHALL REPRESENT A CROSS SECTION OF THE ECONOMIC COMPOSITION OF FREDERICK COUNTY AND SHALL BE SELECTED BECAUSE OF THEIR KNOWN EXPERIENCE AND INTEREST IN THE DEVELOPMENT OF FREDERICK COUNTY;

(2) THAT THE COMMISSION MAY:

(I) INVESTIGATE AND ASSEMBLE INFORMATION PERTINENT TO THE ECONOMIC RESOURCES AND INDUSTRIAL OPPORTUNITIES OF THE COUNTY;

(II) ENCOURAGE LOCATION OF NEW INDUSTRIAL ENTERPRISES IN THE COUNTY AND THE EXPANSION OF PRESENT ENTERPRISES;

(III) DISSEMINATE INFORMATION IN THE INTEREST OF INDUSTRIAL DEVELOPMENT BY PUBLICATION, ADVERTISING AND OTHER MEANS;

(IV) COOPERATE WITH ANY FEDERAL, STATE, LOCAL AGENCY, BOARD OR COMMISSION INCLUDING THE DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT OF MARYLAND;

(V) COOPERATE WITH ANY INTERESTED PRIVATE CONCERN, CIVIC ORGANIZATION OR SUBDIVISION;

(3) (I) THAT THE MEMBERS OF THE COMMISSION SHALL SERVE FOR TWO YEARS FROM THE EFFECTIVE DATE OF THE CREATION OF THE COMMISSION AND ARE ELIGIBLE FOR REAPPOINTMENT; THAT THEY SHALL SERVE WITHOUT COMPENSATION BUT MAY BE REIMBURSED FOR NECESSARY TRAVEL AND OTHER EXPENSES INCURRED IN THE PERFORMANCE OF THEIR DUTIES; THAT THE COMMISSION SHALL SELECT FROM ITS OWN MEMBERSHIP A CHAIRMAN, VICE CHAIRMAN, AND A SECRETARY-TREASURER, WHO MAY NOT BE THE SAME PERSON, TO SERVE A TERM OF ONE YEAR AND BE ELIGIBLE FOR REELECTION; THAT A PERSON MAY NOT HOLD THE POSITION OF CHAIRMAN FOR MORE THAN THREE CONSECUTIVE TERMS; THAT UPON THE DEATH, DISABILITY,
