MARYLAND RULES.

- (2) THE COMMENCEMENT OF APPELLATE PROCEEDINGS DOES NOT OPERATE AS A STAY OF ANY RULE, REGULATION, STANDARD OR ORDER ISSUED BY THE COMMISSIONER UNDER THE PROVISIONS OF THIS SUBTITLE, EXCEPT THAT THE COURT, AFTER NOTICE TO THE COMMISSIONER AND HEARING, MAY GRANT A STAY UPON SUCH CONDITION OR SUCH SECURITY OR BOND AS MAY, IN ITS DISCRETION, SEEM PROPER.
- (B) (1) IN ANY PROCEEDING UNDER THIS SECTION, THE RULES, REGULATIONS AND STANDARDS OF THE COMMISSIONER ARE PRIMA FACIE LAWFUL AND REASONABLE.
- (2) THE RULES, REGULATIONS AND STANDARDS ARE NOT INVALID BECAUSE OF TECHNICAL DEFECT IF THERE IS SUBSTANTIAL COMPLIANCE WITH THE PROVISIONS OF THIS SUBTITLE.
- (C) THE COMMISSIONER MAY ENFORCE ANY RULE, REGULATION, STANDARD OR ORDER BY FILING A PETITION FOR RELIEF IN A COURT OF COMPETENT JURISDICTION IN ACCORDANCE WITH THE MARYLAND ADMINISTRATIVE PROCEDURE ACT AND THE MARYLAND RULES.
- (D) UPON REQUEST OF THE COMMISSIONER, THE ATTORNEY GENERAL MAY PROCEED IN A COURT OF THIS OR ANY OTHER STATE OR IN ANY FEDERAL COURT OR AGENCY TO ENFORCE ANY ORDER, DECISION, OR THE COLLECTION OF ANY CIVIL PENALTY ASSESSED BY THE COMMISSIONER UNDER THIS SUBTITLE.
- (E) PETITIONS FILED UNDER THIS SECTION SHALL BE HEARD EXPEDITIOUSLY.

- (A) EVERY OWNER OR LESSEE OF AMUSEMENT RIDES OR ATTRACTIONS OPERATED IN THE STATE SHALL:
- (1) MAKE, KEEP, AND PRESERVE AND MAKE AVAILABLE TO THE COMMISSIONER OR HIS AUTHORIZED REPRESENTATIVE FOR INSPECTION OF HIS ACTIVITIES:
- (2) MAINTAIN ACCURATE FECORDS OF AND MAKE PERIODIC REPORTS ON INJURIES TO THE PUBLIC INCURRED IN THE USE OF SUCH AMUSEMENT RIDE OR ATTRACTION OTHER THAN MINOR INJURIES REQUIRING ONLY FIRST AID TREATMENT AND WHICH DO NOT INVOLVE MEDICAL TREATMENT OR LOSS OF CONSCIOUSNESS: AND
- (3) ON THE BASIS OF THE RECORDS MADE AND KEPT, FILE REPORTS WITH THE COMMISSIONER.
- (B) NOTWITHSTANDING ANY OTHER PROVISION OF THIS SECTION, EVERY OWNER OR LESSEE OF AN AMUSEMENT RIDE OR ATTRACTION SHALL REPORT, IN WRITING OR ORALLY, TO THE COMMISSIONER, WITHIN 72 HOURS AFTER HIS NOTIFICATION, OF THE OCCURRENCE OF ANY ACCIDENT, OTHER [[OF]] THAN THOSE
