

RESIGNATION, OR REMOVAL OF ANY MEMBER OF THE COMMISSION, THE COUNTY COMMISSIONERS SHALL APPOINT A PERSON TO SERVE FOR THE UNEXPIRED TERM;

(II) THAT THE STATE SENATORS FOR FREDERICK COUNTY AND THE PRESIDENT OF THE BOARD OF COUNTY COMMISSIONERS SHALL SERVE AS EX OFFICIO MEMBERS OF THE ECONOMIC DEVELOPMENT COMMISSION WITHOUT THE POWER TO VOTE;

(4) THAT THE COMMISSION HAS THE POWER TO ESTABLISH AND APPOINT ADVISORY GROUPS AND COMMITTEES TO ASSIST IN ITS PROGRAM OF ACTIVITY OF WHICH MEMBERSHIP IS NOT RESTRICTED SOLELY TO MEMBERS OF THE COMMISSION;

(5) THAT THE COMMISSION SHALL MEET MONTHLY AND SHALL HOLD SPECIAL MEETINGS WHENEVER REQUESTED BY THE CHAIRMAN OR ANY THREE MEMBERS OF THE COMMISSION; THAT THE COMMISSION SHALL ADOPT RULES AND REGULATIONS AS IT CONSIDERS NECESSARY TO GOVERN PROCEDURE AND BUSINESS; THAT A SIMPLE MAJORITY CONSTITUTES A QUORUM; THAT THE COMMISSION SHALL SUBMIT TO THE BOARD OF COUNTY COMMISSIONERS OF FREDERICK COUNTY AN ANNUAL OPERATING BUDGET FOR THE FISCAL YEAR FOR THE APPROVAL OF THE COUNTY COMMISSIONERS, AND THE COUNTY COMMISSIONERS SHALL PROVIDE THE FUNDS APPROVED BY THEM; THAT THE COMMISSION MAY EMPLOY EMPLOYEES AS REQUIRED, BUT WITHIN THE LIMITS OF ITS BUDGET; THAT ANY NEWLY CREATED POSITION AND SALARY SHALL RECEIVE THE APPROVAL OF THE COUNTY COMMISSIONERS; THAT THE TITLE OF THE POSITION OR POSITIONS TO BE CREATED SHALL BE APPROVED BY THE COUNTY COMMISSIONERS, BUT THE APPOINTMENT OF A PERSON SHALL BE SUBJECT TO THE APPROVAL OF THE ECONOMIC DEVELOPMENT COMMISSION; AND

(6) THAT ANNUAL REPORTS SHALL BE FILED WITH THE BOARD OF COUNTY COMMISSIONERS OF FREDERICK COUNTY AND MADE AVAILABLE TO THE PUBLIC; AND THAT THE ANNUAL REPORT SHALL INCLUDE SUBJECTS AND RECOMMENDATIONS FOR THE IMPROVEMENT AND ADVANCEMENT OF THE ECONOMIC WELFARE OF THE PEOPLE OF FREDERICK COUNTY.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1976.
