BY repealing and reenacting, with amendments,

Article 27 — Crimes and Punishments Section 594B(f) (6) Annotated Code of Maryland (1971 Replacement Volume and 1975 Supplement)

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That new Section 83 be and it is hereby aided to Article 77A — Higher Education, of the Annotated Code of Maryland (1975 Replacement Volume and 1975 Supplement) to read as follows:

Article 77A - Higher Education

83.

- (A) A MEMBER OF THE MORGAN STATE UNIVERSITY POLICE IS AND HAS THE POWERS OF A PEACE AND POLICE OFFICER ONLY ON PROPERTY OWNED, LEASED, OPERATED, OR UNDER THE CONTROL OF MORGAN STATE UNIVERSITY.
- MEMBERS OF THE MORGAN STATE UNIVERSITY POLICE NOT MAY ACT ON PROPERTY WHICH IS NOT CWNED, LEASED, OPERATED, OR UNDER THE CONTROL OF MORGAN STATE UNIVERSITY EXCEPT: (1) WHEN IN HOT PURSUIT OF A SUSPECTED OFFENDER; [[(2) WHEN IN SEARCH OF AN OFFENDER WANTED FOR A CRIME COMMITTED ON PROPERTY OWNED, LEASED, OPERATED, OR UNDER THE CONTROL OF MORGAN STATE UNIVERSITY]][[, OR WHEN SEEKING TO INTERVIEW A WITNESS OR SUPPOSED WITNESS TO A CRIME COMMITTED ON PROPERTY OWNED, LEASED, OPERATED, OR UNDER THE CONTROL OF MORGAN STATE UNIVERSITY]]; [[(3)]] (2) WHEN NECESSARY IN ORDER TO FACILITATE THE ORDERLY INGRESS OR EGRESS OF TRAFFIC TO AND FROM PROPERTY OWNED, LEASED, OPERATED, OR UNDER THE CONTROL OF MORGAN STATE UNIVERSITY; OR [[(4]]] (3) [[WHEN SPECIFICALLY REQUESTED OR PERMITTED TO SO ACT BY THE CHIEF EXECUTIVE OFFICER OR THE CHIEF POLICE OFFICER OF ANY POLITICAL SUBDIVISION; OR (5) ]] WHEN ORDERED TO SO ACT BY THE GOVERNOR.
- THE BOARD OF TRUSTEES, IN CONSULTATION SUPERINTENDENT OF THE MARYLAND STATE FOLICE AND THE MARYLAND POLICE TRAINING COMMISSION, SHALL ESTABLISH AND PROMULGATE STANDARDS, QUALIFICATIONS AND PRESEQUISITES OF CHARACTER, TRAINING, EDUCATION, HUMAN AND PUBLIC RELATIONS AND EXPERIENCE FOR THE MORGAN STATE UNIVERSITY POLICE, INCLUDING STANDARDS FOR THE PERFORMANCE OF THEIR HOWEVER, THE STATUS OF ANY PRESENTLY QUALIFIED DUTIES. MEMBER OF THE MORGAN STATE UNIVERSITY POLICE MAY CURRENT NOT BE AFFECTED IN THE FUTURE BY STANDARDS ESTABLISHED THE PROMUL GAT ED PELATING TO MINIMUM HIRING QUALIFICATIONS OF MORGAN STATE UNIVERSITY TO THE EXTENT PRACTICAL THE BOARD OF TRUSTEES OFFICERS. SHALL ESTABLISH AND PROMULGATE STANDARDS WHICH WITH THE STANDARDS FOR THE MARYLAND STATE CONSISTENT POLICE. MORGAN STATE UNIVERSITY SHALL ESTABLISH RULES AND REGULATIONS GOVERNING THE OPERATION AND CONDUCT FOR
