

OF ARTICLE XI-E OF THE CONSTITUTION OF MARYLAND AND THE PROVISIONS OF ARTICLE 23A OF THE ANNOTATED CODE OF MARYLAND (1957 EDITION, AS AMENDED), TITLE "CORPORATIONS-MUNICIPAL"; TO AMEND THE CHARTER OF THE CITY OF HAVRE DE GRACE, MARYLAND, BY REPEALING SECTION 364 THROUGH 378 INCLUSIVE OF THE CODE OF PUBLIC LOCAL LAWS OF HARFORD COUNTY (1965 EDITION, AS AMENDED), BEING ARTICLE 13 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND, TITLE "HARFORD COUNTY", SUBTITLE "HAVRE DE GRACE"; AND ENACTING NEW SECTIONS TO PROVIDE FOR THE ABOLITION OF THE MUNICIPAL UTILITIES COMMISSION, THE TRANSFER OF ITS POWERS, FUNCTIONS, EMPLOYEES, PROPERTY AND RECORDS TO THE MAYOR AND CITY COUNCIL OF HAVRE DE GRACE; PROVIDING FOR THE CREATION OF A DEPARTMENT OF PUBLIC WORKS, THE APPOINTMENT OF A DIRECTOR; SETTING FORTH HIS POWERS AND DUTIES AND ENACTING NEW SECTIONS TO PROVIDE FOR THE POWERS OF THE MAYOR AND CITY COUNCIL OVER THE PUBLIC WAYS AND SIDEWALKS, AND WATER SUPPLIES AND SEWERS, AND TO CONSTRUCT, RECONSTRUCT, MAINTAIN AND REGULATE SUCH PUBLIC WAYS, SIDEWALKS, WATER SUPPLIES AND SEWERS; TO PROVIDE FOR CHARGES FOR THE CONNECTION TO AND USE OF THE WATER AND SEWER SYSTEMS; TO REGULATE PRIVATE SYSTEMS, TO PROHIBIT ACTIVITY WHICH MAY INTERFERE WITH SUCH SYSTEMS AND GRANTING THE MAYOR AND CITY COUNCIL THE POWER TO ENACT ORDINANCES IN FURTHERANCE OF THE POWERS GRANTED BY THESE SECTIONS.

RESOLUTION NO. 109

(Charter Amendment)

A RESOLUTION BY THE MAYOR AND CITY COUNCIL OF HAVRE DE GRACE, MARYLAND, ADOPTED PURSUANT TO THE AUTHORITY OF ARTICLE XI-E OF THE CONSTITUTION OF MARYLAND AND THE PROVISIONS OF ARTICLE 23A OF THE ANNOTATED CODE OF MARYLAND (1957 EDITION, AS AMENDED) ENTITLED "CORPORATIONS-MUNICIPAL" TO AMEND THE CHARTER OF THE CITY OF HAVRE DE GRACE, MARYLAND, BY ADDING NEW SECTION 313A ENTITLED "ENTERPRISE ACCOUNTING" TO THE CODE OF PUBLIC LOCAL LAWS OF HARFORD COUNTY (1965 EDITION, AS AMENDED) BEING ARTICLE 13 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND, TITLE "HARFORD COUNTY", SUBTITLE "HAVRE DE GRACE", PROVIDING FOR THE SEPARATION OF FUNDS DERIVED FROM PUBLIC
