SHALL BE MAINTAINED FOR AT LEAST THREE YEARS.

- (H) THE USE OF CRIMINAL HISTORY RECORD INFORMATION BY AN AUTHORIZED AGENCY OR INDIVIDUAL IS LIMITED TO THE SPECIFIC PURPOSE OR PURPOSES STATED IN THIS SECTION AND MAY NOT BE DISSEMINATED FURTHER EXCEPT IN ACCORDANCE WITH SPECIFIC AUTHORIZATION.
- (I) CRIMINAL HISTORY RECORD INFORMATION CONCERNING A CHARGE RESULTING FROM THE ARREST OF A PERSON MAY NOT BE DISSEMINATED TO A NONCRIMINAL JUSTICE AGENCY OR INDIVIDUAL IF:
- (1) AN INTERVAL OF ONE YEAR HAS ELAPSED FROM THE DATE OF THE ARPEST, AND
- (2) DISPOSITION OF THE CHARGE RESULTING FROM THE ARREST HAS NOT BEEN REPORTED, AND
- (3) ACTIVE PROSECUTION OF THE CHARGE IS NOT PENDING.
- (J) IN ADDITION TO ANY OTHER REMEDY OR PENALTY AUTHORIZED BY LAW, ANY INDIVIDUAL VIOLATING OR CAUSING A VIOLATION OF THE PROVISIONS OF THIS SECTION IS GUILTY OF A MISDEMEANOR, AND UPON CONVICTION, IS SUBJECT TO A FINE OF NOT MORE THAN \$5,000 OR IMPRISONMENT FOR NOT MORE THAN SIX MONTHS OR BOTH FOR EACH VIOLATION. IF THE PERSON IS EMPLOYED OR LICENSED BY A STATE OR LOCAL GOVERNMENT AGENCY, A CONVICTION SHALL CONSTITUTE GOOD CAUSE TO TERMINATE HIS EMPLOYMENT OR TO REVOKE OR SUSPEND HIS LICENSE.

750. DISCLOSURE OF CURRENT STATUS.

NOTWITHSTANDING THE PROVISIONS OF § 749, A CRIMINAL JUSTICE AGENCY MAY DISCLOSE THE STATUS OF A PENDING INVESTIGATION OF A NAMED PERSON, OR THE STATUS OF A PENDING PROCEEDING IN THE CRIMINAL JUSTICE SYSTEM, IP THE REQUEST FOR INFORMATION IS REASONABLY CONTEMPORANEOUS WITH THE EVENT TO WHICH THE INFORMATION RELATES AND THE DISCLOSURE IS OTHERWISE APPROPRIATE.]

[[750A]] 750. NOTWITHSTANDING ANY OTHER PROVISIONS OF THIS SUBTITLE NO RECORD MAY BE MAINTAINED OR DISSEMINATED INCONSISTENTLY WITH THE PROVISIONS OF SECTION 735 THROUGH 741 OF ARTICLE 27.

751. RIGHT OF INSPECTION.

- (A) SUBJECT TO THE PROVISIONS OF §752 (F), A PERSON MAY INSPECT CRIMINAL HISTORY RECORD INFORMATION MAINTAINED BY A CRIMINAL JUSTICE AGENCY CONCERNING HIM. A PERSON'S ATTORNEY MAY INSPECT SUCH INFORMATION IF HE SATISFACTORILY ESTABLISHES HIS IDENTITY AND PRESENTS A WRITTEN AUTHORIZATION FROM HIS CLIENT.
 - (B) NOTHING IN THIS SECTION REQUIRES A CRIMINAL
