

THE FINAL REQUIRED STATE CONTRIBUTION CALCULATED IN ACCORDANCE WITH §106E-3(C) (7) .

(4) FOR FISCAL YEAR 1979:

(I) THE COUNTY CONTRIBUTION SHALL BE AN AMOUNT EQUAL TO ITS 1976 COUNTY BASE, SET FORTH IN SUBSECTION ~~[(D)]~~ (C) (1), PLUS OR MINUS, AS THE CASE MAY BE, 60 PERCENT OF THE DIFFERENCE BETWEEN THAT COUNTY BASE AND THE FINAL REQUIRED LOCAL CONTRIBUTION CALCULATED IN ACCORDANCE WITH §106E-3(C) (6). IF THE FINAL REQUIRED LOCAL CONTRIBUTION IS HIGHER THAN THE 1976 COUNTY BASE, THE PERCENTAGE OF THE DIFFERENCE SHALL BE ADDED TO THE COUNTY BASE; OTHERWISE, IT SHALL BE SUBTRACTED;

(II) THE STATE CONTRIBUTION FOR EACH COUNTY SHALL BE AN AMOUNT EQUAL TO THE 1976 STATE BASE FOR THE COUNTY, SET FORTH IN SUBSECTION ~~[(D)]~~ (C) (1) PLUS 60 PERCENT OF THE DIFFERENCE BETWEEN THAT BASE AND THE FINAL REQUIRED STATE CONTRIBUTION CALCULATED IN ACCORDANCE WITH §106E-3 (C) (7) .

(5) FOR FISCAL YEAR 1980:

(I) THE COUNTY CONTRIBUTION SHALL BE AN AMOUNT EQUAL TO ITS 1976 COUNTY BASE, SET FORTH IN SUBSECTION ~~[(D)]~~ (C) (1), PLUS OR MINUS, AS THE CASE MAY BE, 80 PERCENT OF THE DIFFERENCE BETWEEN THAT COUNTY BASE AND THE FINAL REQUIRED LOCAL CONTRIBUTION CALCULATED IN ACCORDANCE WITH §106E-3(C) (6). IF THE FINAL REQUIRED LOCAL CONTRIBUTION IS HIGHER THAN THE 1976 COUNTY BASE, THE PERCENTAGE OF THE DIFFERENCE SHALL BE ADDED TO THE COUNTY BASE; OTHERWISE, IT SHALL BE SUBTRACTED;

(II) THE STATE CONTRIBUTION FOR EACH COUNTY SHALL BE AN AMOUNT EQUAL TO THE 1976 STATE BASE FOR THE COUNTY, SET FORTH IN SUBSECTION ~~[(D)]~~ (C) (1) PLUS 80 PERCENT OF THE DIFFERENCE BETWEEN THAT BASE AND THE FINAL REQUIRED STATE CONTRIBUTION CALCULATED IN ACCORDANCE WITH §106E-3 (C) (7) .

(D) THE STATE AND THE COUNTIES SHALL, COLLECTIVELY, SHARE IN THE COST OF EDUCATING HANDICAPPED CHILDREN IN NONPUBLIC PROGRAMS AS SET FORTH IN §106D(G) ON THE FOLLOWING BASIS:

(1) THE COUNTY SHALL FIRST CONTRIBUTE THE AMOUNTS PROVIDED FOR IN §106E-3(D) (1) FOR EACH SUCH CHILD DOMICILED IN THE COUNTY.

(2) THE STATE SHALL CONTRIBUTE, FOR EACH SUCH CHILD;

(I) FOR FISCAL YEAR 1977, AN AMOUNT EQUAL TO AT LEAST 20 PERCENT OF THE AMOUNT REQUIRED UNDER §106E-3(D) (2); PROVIDED THAT FOR FISCAL YEAR 1977 THE STATE MAY CONTRIBUTE SUCH ADDITIONAL AMOUNT IN EXCESS OF 20 PERCENT AS PROVIDED BY LAW;
