TESTS ON HIS OWN PATIENTS, SHALL FILE WITH THE SECRETARY AN APPLICATION SETTING FORTH THE NAME OF THE OWNER, THE TYPE]] BX CEPT A LICENSED PHYSICIAN, HOSPITAL, CLINIC OR OTHER AGENCY LICENSED OR REGULATED BY THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE, SHALL FILE WITH THE SECRETARY AN APPLICATION SETTING FORTH THE NAME AND ADDRESS OF THE OWNER, THE TYPES OF TESTS PERFORMED, AND ANY OTHER INFORMATION AS THE SECRETARY MAY REQUIRE. THE SECRETARY INFORMATION AS THE SECRETARY MAY REQUIRE. SHALL CAUSE AN INSPECTION TO BE MADE AND, IF IN COMPLIANCE WITH THE MINIMUM STANDARDS AND QUALIFICATIONS AND UPON PAYMENT OF THE FEES AUTHORIZED, HE SHALL ISSUE A PERMIT TO OPERATE, WHICH SHALL BE CONSPICUOUSLY DISPLAYED BY THE [[MOBILE]] MEDICAL TEST UNIT. A [MOBILE]] MEDICAL UNIT MAY NOT OFFER OR ADMINISTER ANY TEST UNLESS APPROPRIATE APPROVAL IS RECEIVED FROM THE SECRETARY. THE SECRETARY SHALL CONDUCT PERIODIC INSPECTIONS TO INSURE PERSON, PARTNERSHIP, CONTINUING COMPLIANCE. A ASSOCIATION, OR CORPORATION MAY NOT OPERATE A [[MOBILE]]
MEDICAL TEST UNIT WITHOUT THIS PERMIT.

- (D) THE SECRETARY MAY REFUSE TO ISSUE, SUSPEND OR REVOKE A PERMIT TO OPERATE, IF, AFTER INSPECTION AND DUE NOTICE, A [[MOBILE]] MEDICAL TEST UNIT FAILS TO COMPLY WITH THE MINIMUM STANDARDS OR QUALIFICATIONS OR WITH THE PROVISIONS OF ANY RULES OR REGULATIONS REGULARLY ADOPTED BY THE SECRETARY.
- (E) THE SECRETARY SHALL FSTABLISH REASONABLE APPLICATION AND ANNUAL REGISTRATION FEES FOR PERMITTEES UNDER THIS SECTION. THESE FEES ARE PAYABLE TO [[MOBILE TEST UNIT ADMINISTRATION,]] THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE, FOR DEPOSIT BY THE DEPARTMENT IN THE GENERAL FUNDS OF THE STATE.
- (P) ANY PERSON VIOLATING THIS SECTION IS GUILTY OF A MISDEMEANOR AND, UPON CONVICTION IS LIABLE FOR A FINE OF NOT MORE THAN \$100 FOR THE FIRST OFFENSE, AND NOT MORE THAN \$500 FOR EACH SUCCESSIVE OFFENSE. EACH DAY A VIOLATION IS CONTINUED AFTER THE FIRST CONVICTION IS CONSIDERED A SECOND OFFENSE.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1976.
