- [[(E)]] (F) ON RECEIPT OF NOTICE GIVEN UNDER THIS SECTION, THE OWNER MAY WITHHOLD, FROM SUMS DUE THE CONTRACTOR, THE AMOUNT THE OWNER ASCERTAINS TO BE DUE THE SUBCONTRACTOR GIVING THE NOTICE. IF THE SUBCONTRACTOR GIVING NOTICE ESTABLISHES A LIEN IN ACCORDANCE WITH THIS SUBTITLE, THE CONTRACTOR SHALL RECEIVE ONLY THE DIFFERENCE BETWEEN THE AMOUNT DUF HIM AND THAT DUE THE SUBCONTRACTOR GIVING THE NOTICE.
