metropolitan commission system, only a minimum front foot levy shall be charged. As used [herein] IN THIS PARAGRAPH CLAUSE (1) ONLY, "community associations" means THOSE incorporated associations whose membership is limited to voluntary subscriptions by residents of the communities or development and which have no power either by law, covenant, or any other means to assess fees against residents or property owners based on property values[.]; AND (2) FROM COUNTY TAXATION ONLY, THE COUNTY COUNCIL MAY ALLOW TAX CREDITS FOR REAL AND TANGIBLE PEPSONAL PROPERTY OWNED BY COMMUNITY ASSOCIATIONS ANY COMMUNITY ASSOCIATION, NOT LIMITED AS IN CLAUSE (1), AND USED FOR COMMUNITY, CIVIC, EDUCATIONAL, LIBRARY, OF PARK PURPOSES. THESE CREDITS MAY NOT BE GRANTED FOR ANY SWIMMING POOLS, TENNIS COURTS, OR SIMILAR PECPEATIONAL FACILITIES.

- (O-1) IN WASHINGTON COUNTY, FROM COUNTY TAXATION ONLY, REAL PROPERTY ON WHICH IMPROVEMENTS ARE MADE TO EXISTING STRUCTURES WITHIN AND CONTFOLLED BY ANY HISTOPIC DISTRICT IN THE COUNTY IN ORDER TO ENCOURAGE IMPPOVEMENT AND RECONSTRUCTION OF PROPERTIES LOCATED WITHIN THOSE AREAS, ALL TO BE DONE ACCORDING TO THE FOLLOWING SCHEDULE:
- (I) THE PROPERTY SHALL BE-EXEMPT RECEIVE A CREDIT TO THE EXTENT OF 100 PERCENT OF THE INCREASE IN A SSESSED VALUATION OF THE PROPERTY ATTRIBUTABLE TO THE RECONSTRUCTION AND IMPROVEMENT. THIS EXEMPTION CREDIT SHALL OCCUP IN THE FIRST AND SECOND TAXABLE YEARS IN WHICH THE IMPROVED STRUCTURE IS SUBJECT TO TAXATION.
- (II) FOR THE THIPD TAXABLE YEAR, THE EXEMPTION CREDIT SHALL BE TO THE EXTENT OF 80 PEPCENT OF THE INCREASE IN ASSESSED VALUATION OF THE PROPERTY ATTRIBUTABLE TO THAT PECONSTRUCTION.
- (III) FOR THE FOURTH TAXABLE YEAR, THE EXEMPTION CREDIT SHALL BE TO THE EXTENT OF 60 PERCENT OF THE INCREASE IN ASSESSED VALUATION OF THE PROPERTY ATTRIBUTABLE TO THAT RECONSTRUCTION.
- (IV) FOR THE FIFTH TAXABLE YEAR, THE EXEMPTION CREDIT SHALL BE TO THE EXTENT OF 40 PEPCENT OF THE INCREASE IN ASSESSED VALUATION OF THE PROPERTY ATTRIBUTABLE TO THAT PECONSTRUCTION.
- (V) THEREAFTER, AN EXEMPTION A COPDIT FOR THE PURPOSES OF THIS SUBSECTION MAY NOT BY ALLOWED.
- [(u) In Washington County, from county taxation only, real property on which improvements are made to existing structures within and controlled by any historic district in Washington County so as to encourage improvement and reconstruction of those properties located within those areas, all to be done according to the following schedule:
