OF THE BOARD OF EDUCATION OF MONTGOMERY COUNTY, THERE IS A NONVOTING STUDENT MEMBER WHO MUST BE A BONA FIDE RESIDENT OF MONTGOMERY COUNTY AND A REGULARLY ENROLLED JUNIOR OR SENIOR YEAR STUDENT FROM A MONTGOMERY COUNTY PUBLIC HIGH SCHOOL.

- (2) THE STUDENT MEMBER SHALL SERVE FOR ONE YEAR AND SHALL BE ELECTED IN THE YEAR PRICE TO HIS OR HER TERM. THE TERM OF THE FIRST STUDENT MEMBER SHALL BEGIN JULY 1, 1978.
- (3) THE NOMINATION AND ELECTION PROCESS SHALL BE AS MUTUALLY AGREED UPON BY THE BOARD AND THE MONTGOMERY COUNTY REGION OF THE MARYLAND ASSOCIATION OF STUDENT COUNCILS. THE PROCESS SHALL INCLUDE, BUT NOT BE LIMITED TO, THE OPPORTUNITY FOR ANY STUDENT ENROLLED IN GRADES 9 THROUGH 11 IN THE MONTGOMERY COUNTY PUBLIC SCHOOLS (I) TO NOMINATE A STUDENT MEMBER CANDIDATE; AND (II) TO VOTE EITHER DIRECTLY FOR A STUDENT BOARD MEMBER, OR TO VOTE FOR DELEGATES FROM THE STUDENT'S SCHOOL WHO, IN TURN, VOTE FOR THE STUDENT BOARD MEMBER.
- (4) AN ALTERNATE STUDENT MEMBER SHALL BE ELECTED AT THE SAME TIME AS THE STUDENT MEMBER. THE ALTERNATE SHALL SERVE ONLY IF THE STUDENT MEMBER IS UNABLE TO COMPLETE THE ESTABLISHED TERM FOR WHICH HE OR SHE IS ELECTED.
- PROVIDED IN THIS PARAGRAPH, THE STUDENT MEMBER HAS THE SAME RIGHTS AND PRIVILEGES OF THE OTHER BOARD MEMBERS. HOWEVER, THE STUDENT MEMBER MAY NOT VOTE, AND MAY NOT ATTEND EXECUTIVE SESSIONS WHICH RELATE TO HEARINGS ON APPEALS OF SPECIAL EDUCATION PLACEMENTS, HEARINGS HELD PURSUANT TO SECTION 114 OF THIS ARTICLE, OR COLLECTIVE BARGAINING, UNLESS INVITED TO ATTEND BY AN AFFIRMATIVE VOTE OF A MAJORITY OF THE BOARD OF EDUCATION. THE STUDENT MEMBER MAY BE REIMBURSED ONLY FOR OUT-OF-POCKET EXPENSES IN CONNECTION WITH OFFICIAL DUTIES, WHICH MUST BE VOUCHERED.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1977.

CHAPTER 149

(House Bill 1814)

AN ACT concerning

Washington County - Capital Budget

FOR the purpose of requiring that a capital kudget and
