In subsection (b) (2) of this section, the defined term "State airway" is substituted for "airways system, or parts thereof" for clarity. Also, the terms "expanded, or modified" are added to conform to the language appearing in subsection (b) (1) of this section.

The only other changes are in style.

5-208. RULES, REGULATIONS, AND STANDARDS.

## (A) GENERAL POWERS.

- (1) THE ADMINISTRATION MAY PERFORM ANY ACT, ISSUE AND AMEND ANY ORDER, ALOPT AND AMEND ANY GENERAL OR SPECIAL RULE, REGULATION, OR PROCEDURE, AND ESTABLISH ANY MINIMUM STANDARD CONSISTENT WITH THIS TITLE AND NECESSARY:
- (I) TO PERFORM ITS DUTIES AND CARRY OUT THE PROVISIONS OF THIS TITLE;
- (11) TO PROTECT THE GENERAL PUBLIC SAFETY, THE SAFETY OF PERSONS WHO OPERATE, USE, OR TRAVEL IN AIRCRAFT, THE SAFETY OF PERSONS WHO RECEIVE INSTRUCTIONS IN FLYING OR GROUND SUBJECTS THAT RELATE TC ABBONAUTICS, OR THE SAFETY OF PERSONS AND PROPERTY ON LAND OR WATER; OR
- (111) TO DEVELOP AND PROMOTE AFRONAUTICS IN THIS STATE.
- (2) THE ADMINISTRATION ALSO MAY ADOPT RULES AND REGULATIONS BY WHICH A PERSON ENGAGING IN AERONAUTICS MAY BE REQUIRED TO ESTABLISH PINANCIAL RESPONSIBILITY POR ANY DAMAGE OR INJURY THAT MIGHT BE CAUSED BY THE PERSON.

## (B) EXCEPTIONS.

- (1) A RULE OR REGULATION ADOPTED BY THE ADMINISTRATION MAY NOT APPLY TO ANY AIRPORT, AIRPORT FACILITY, OR AIR NAVIGATION FACILITY THAT IS OWNED OR OPERATED BY THE UNITED STATES.
- (2) A RULE, REGULATION, ORDER, OR STANDARD OF THE ADMINISTRATION MAY NOT BE INCONSISTENT WITH OR CONTRARY TO FEDERAL LAW.
  - (C) FILING OF RULES, REGULATIONS, AND STANDARDS.

COPIES OF ALL RULES, REGULATIONS, AND STANDARDS SHALL BE FILED IN ACCORDANCE WITH THE ADMINISTRATIVE PROCEDURE ACT AND THE STATE DOCUMENTS LAW AND SHALL BE MADE AVAILABLE TO THE PUBLIC.
