right to vote for a candidate OR QUESTION at the approaching election, the circuit court for any county or one of the judges of the Supreme Bench of Baltimore City [may], by order, MAY require the board to correct the error or to show cause why [such] THE error should not be corrected.

The titles of offices may be horizontally or vertically on the ballots, with the names of candidates for an office arranged longitudinally under or transversely opposite the title of his office. The titles of offices shall be so arranged that: shall first appear those titles of public offices for which the voters of the entire State cr cf an entire congressional district may vote as follows: President and Vice-President, Governor and Lieutenant Governor. Comptroller, Attorney General, U. S. Representative; (2) there shall next appear the titles of offices of the Senate and House of Delegates of the General Assembly of Maryland; (3) #There shall next appear the titles of the offices of Mayor, president of the city council, Comptroller and members of the City Ccuncil of Baltimore City or county executive and county council or county commissioners of the respective ccunties; (4) } there shall next appear the titles of candidates for judge of the Court of Appeals and the Court of Special Appeals of Maryland, of the circuit courts of the several counties, and of the Supreme Bench of Baltimore City; -{4}--THERE-SHALL-WEXT-APPEAR-THE-TITLES OF-THE-OFFICES-OF-NAYOR, -PRESIDENT-OF-THE-CITY-COUNCIL, COMPTROLLER-AND-MEMBLES-OF-THE-CITY-COUNCIL-CF-BALTIMORE GETY-OR-GOUNTY-BEEGUTIVE-AND-COUNTY-CGUNCIL-GE-COUNTY COMMISSIONERS-OF-THE RESPECTIVE-COUNTIES; (5) there shall next appear, IN THE FOLLOWING CEDER, the titles of offices for which the voters of the respective counties or Baltimore City may vote, including, but not limited to, the offices of Treasurer, State's Attorney, [clerks] CLERK of the circuit [courts of] CCURT IN the several counties [and of the several courts comprising the Supreme Bench of ] OR CLERKS CF THE SUPERIOR COURT, CIRCUIT COURT NO. 1, CIRCUIT COURT NO. 2, CRIMINAL COURT, EALTIMORE CITY COURT AND COURT OF COMMON PLEAS IN Baltimore City, register of wills, judges of the orphans courts[, sheriff and surveyor], AND SHERIFF; (6) the titles of party offices shall follow the titles of public offices on all ballots.

(b) On or before the fifteenth day preceding an election, the board shall mail to the chairman of the city or county committee, as the case may be, of each political party [entitled under existing law to participate in primary elections within the city or county,] AS DEFINED IN § 1-1(A) (15) AND TO EACH CANDIDATE WHO IS NOT A CANDIDATE OR NOMINEE OF A
