- [A] EVERY HEALTH INSURANCE POLICY DELIVERED OR ISSUED FOR DELIVERY IN THIS STATE WHICH PROVIDES FOR REIMEURSEMENT FOR ANY SERVICE WHICH IS WITHIN THE LAWFUL SCOPE OF PRACTICE OF A DULY LICENSED CERTIFIED SOCIAL WORKER SHALL PROVIDE SUCH EFNEFIT WEETHER THE SERVICE IS PERFORMED BY A DOCTOR OF MEDICINE OR BY A DULY LICENSED CERTIFIED SOCIAL WORKER WHO HAS HAD AT LEAST TWO YEARS OF CHINICAL TRAINING IN AN APPROVED FROGRAM WITHIN AN ACCREDITED HOSPITAL OR CLINICAL PROGRAM AS ESTABLISHED BY THE BOAFD OF SOCIAL WORK EXAMINERS IF THE INSURED OR THE PERSON COVERED BY THE POLICY WAS REFERRED TO THE SOCIAL WORKER BY A PHYSICIAN.

- EVERY GROUP OR BLANKET HEALTH INSURANCE POLICY (A) DELIVERED OR ISSUED FOR DELIVERY IN THIS STATE OR ISSUED TO A GROUP WHICH IS INCORPORATED OR HAS A MAIN OFFICE LOCATED IN THIS STATE, OR COVERING FERSONS WHO RESIDE OR WORK WITHIN THIS STATE, WHICH PROVIDES FOR REIMFURSEMENT FOR ANY SERVICE WHICH IS WITHIN THE LAWFUL SCOPE OF PRACTICE OF A DULY LICENSED CERTIFIED SCCIAL WORKER SHALL PROVIDE SUCH BENEFIT WHETHER THE STRVICE IS PERFORMED BY A DOCTOR OF MEDICINE OR BY A DULY LICENSEL CERTIFIED SOCIAL WORKER WHO HAS HAD AT LEAST TWO YEARS OF CLINICAL TRAINING-IN-AN-APPROVED-PROGRAM-WITHIN-AN-ACCREDITED HOSPITAL GR GLINIC OR 3,000 HCURS OF POST-MASTERS SUPERVISED CLINICAL SOCIAL WORK PRACTICE IN A CLINICAL PROGRAM AS ESTABLISHED BY THE ECARD OF SCCIAL WORK EXAMINERS IF THE INSURED OR THE PERSON COVERED BY THE FOLICY WAS REFERRED TO THE SOCIAL WORKER BY A PHYSICIAN.
