respectively for terms of from one to six years and, as each of these terms expires, and thereafter, a successor shall be appointed by the Governor with the advice and consent of the Senate for a full term of six years.

- The eighth member of the State Board for (3) Community Colleges shall be a student in good standing attending a community college in Maryland who shall be appointed by the Governor, after consideration recommendations of the presidents of the community colleges and with the advice and consent of the Senate, for a term of one year beginning July 1 and ending June TERM TERMINATES SCONER BY REASON OF 30, UNLESS THE RESIGNATION, DISQUALIFICATION, OF REMOVAL FROM OFFICE. THE STUDENT MEMBER SHALL MEET THE SAME QUALIFICATIONS SEEK AND HOLD OFFICE WHICH ARE REQUIRED OF THE PRESIDENT OF THE STUDENT GOVERNMENT ASSOCIATION, BY WHATEVER NAME KNOWN, OF THE COMMUNITY COLLEGE WHICH THE STUDENT MEMBER ATTENDS. THE STUDENT MEMBER SHALL BE A RESIDENT THAT MEMBER IS SUBJECT TO REMOVAL FROM OFFICE IN-THE-MANNER-PROVIDED-FOR-REMOVAL-FROM-OFFICE-CF-MEMBERS OF-THE-STUDENT-GOVERNMENT-ASSOCIATION-OF-THE-COMMUNITY COLLEGE-SHICH-THE STUDENT-MEMBER-ATTENDS-
- (4) A member of the Board may be appointed to successive terms.

- (b) (1) The board of trustees shall consist of 11 members, all of whom shall be citizens of the State appointed by the Governor.
- One of the members shall be a student (2) is 18 years of age or older and a full-time undergraduate in good academic standing at a State college. The student shall be appointed for a term of one year, commencing on July 1 AND ENDING THE FOLLOWING JUNE 30, UNLESS THE TERM TERMINATES SCONER BY REASON OF RESIGNATION, DISQUALIFICATION, OR REMOVAL FROM OFFICE. the first year of student membership the student member shall be chosen from the first chartered State college. In the second term of student membership the student shall be chosen from the second chartered State college. In the third term of student membership the student shall be chosen from the third chartered State This system of rotation shall continue until college. all State colleges have been represented. When all State colleges have been represented, the rotation system shall be repeated. THE STUDENT MEMBER SHALL MEET QUALIFICATIONS TO SEEK AND HOLD OFFICE WHICH ARE REQUIRED PRESIDENT OF THE STUDENT GOVERNMENT ASSOCIATION, OF THE BY WHATEVER NAME KNOWN, OF THE STATE COLLEGE WHICH STUDENT MEMBER ATTENDS.
