ANNUAL -- ASSESSMENT -- ON ALL-PROPERTIES-IN-THE-BONNIE-BROOK SANITARY-DISTRICT-NOT-IMPROVED-BY-A-DWELLING---BUT--WHICH LOTS--ARE-BINDING-UPON-A-STREET,-ROAD,-ALLEY,-OP RIGHT-OF-WAY-IN-WHICH-A-WATER-MAIN-HAS-BEEN-BUILT----THE ANNUAL-ASSESMENT-SHALL-BE-MADE-UPGN-A-FRONT-FCOT-BASIS-AND-SHALL-BE-SUBJECT-TO--UNIFORM--RULES--AND--REGULATIONS WITHIN -- THE -- DISTRICT -- APPROVED -- BY -- THE - DISTRICT -- AND - THE COUNTY-COMMISSIONERS-OF---DORCHESIER---COUNTY----THOSE PROPERTIES -- IMPROVED -- BY-A-DWELLING-IN-IHE-BISTRICE-SHALL THESE-ASSESSMENTS-SHALL-BE-SUBJECT-IQ-IHE-AFFRCVAL-CF-THE GGUNTY---COMMISSIONERS--OF---DORCHESTER---CGUNTY---THIS AUTHORIZATION-IS-TO-ENABLE-THE-DORCHESTER-CCUNTY-SANITARY COMMISSION-TO-DEFRAY-THE-COST,-MAINTENANCE,-REPAIRS,--AND OPERATING-EXPANSES-OF-THE-BONNIE-BROOK-SANITARY-DISTRICT, WHICH---DISTRICT---PROVIDES---ONLY--WATER--SERVICES+---IN DORCHESTER COUNTY, THE DORCHESTEF COUNTY SANITARY COMMISSION MAY FIX AND ASSESS A UNIFORM ANNUAL ASSESSMENT ON ALL LCTS IN THE BONNIE BROCK SANITARY DISTRICT, WHETHER OR NOT THE LOT IS IMPFOVED BY A DWEILING CONNECTED TO THE WATER SYSTEM IN THE DISTRICT OR AN UNIMPROVED LOT NOT CONNECTED TO THE WATER SYSTEM IN THE DISTRICT, BUT WHICH BIND UPON A STREET, ROAD, ALIEY OR RIGHT-OF-WAY IN WHICH A WATER MAIN HAS BEEN BUILT FOR THE PURPOSE OF ENABLING THE DORCHESTER COUNTY SANITARY DISTRICT TO DEFRAY THE COST OF CAPITAL IMPROVEMENTS AND REPAIRS TO THE WATER SYSTEM AND TO ESTABLISH A REASCNABLE RESERVE FOR FUTURE CAPITAL IMPROVEMENTS AND REPAIRS TO THE WATER SYSTEM IN THE DISTRICT. THE ANNUAL ASSESSMENT SHALL BE MADE UPON A FLAT FEE PER LOT CHARGE, AND IS TO UNIFORM RULES AND FEGULATIONS WITH THE APPROVED BY THE DISTRICT AND THE COUNTY COMMISSIONERS OF DORCHESTER COUNTY. THIS AUTHORIZATION IS IN ADDITION TO THE AUTHORITY CONTAINED IN SECTION 663 THIS SUBTITLE WHICH PROVIDES FOR A READY-TO-SERVE CHARGE AND METERED RATE CHARGE FOR PROPERITES CONNECTED AND USING A WATER SYSTEM WITHIN A SANITARY DISTRICT AND IS FOR THE EXPRESS PURPOSE OF ENABLING THE DORCHESTER COUNTY SANITARY DISTRICT TO MAKE CAPITAL IMPROVEMENTS OF REPAIRS AND TO ESTABLISH A REASONABLE RESERVE FOR CAPITAL IMPROVEMENTS AND REPAIRS OF THE BONNIE BROOK SANIFARY DISTRICT, WHICH DISTRICT PROVIDES ONLY WATER SERVICES.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1977.
