SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That new Section 35A(j) be and it is hereby added to Article 27 — Crimes and Punishments, of the Annotated Code of Maryland (1976 Replacement Volume and 1976 Supplement) to read as follows:

Article 27 - Crimes and Funishments

35A.

- (J) IHE-SECRETARY-OF-THE-DEPARTMENT-OF-HUMAN RESOURCES-SHALL-ADOPT-RULES-AND-REGULATIONS-TO-ENSURE-THE PROFECTION-OF-INDIVIDUAL-RIGHTS--THESE-SHALL-INCLUBE-THE FOLLOWING:
- (1) NOTICE-BEING-SENT-TO-A-SUSPECTED--GHILD ABUSER
- 42) AN--ADMINISTRATIVE--HEARING--FOR---A
  SUSPECTED-CHILD-ABUSER.
- (3) EXPUNCEMENT—OF—ALL—REFERENCES—TO——A
  SUSPECTED—CHILD—ABUSER\*S—NAME—IP—HIS—NAME—WAS
  INAPPROPRIATELY—PLACED—IN—THE—CENTEAL—REGISTRY—
- THE SECRETARY OF THE DEPARTMENT OF HUMAN RESOURCES SHALL ADOPT RULES AND REGULATIONS NECESSARY TO PROTECT THE RIGHTS OF SUSPECTED CHILD ABUSERS. THE RULES AND REGULATIONS SHALL INCLUDE THE FCILOWING:
- THE SUSPECTED CHILD ABUSER PRIOR TO THE ENTRY OF HIS NAME TO THE CHILD ABUSE CENTRAL REGISTRY.
- 42) UPON REQUEST OF THE SUSPECTED CHILD ABUSER, THE DEPARTMENT OF HUMAN RESOURCES SHALL CONVENE AN ADMINISTRATIVE HEARING FOR THE FURECSE OF ALLOWING THE SUSPECTED CHILD ABUSER TO APPEAL THIS ENTRY. THIS ADMINISTRATIVE HEARING SHALL BE CONVENED IN THE COUNTY OF THE RESIDENCE OF THE SUSPECTED CHILD ABUSER. THIS PARAGRAPH DOES NOT APPLY TO THOSE WHO HAVE BEEN ADJUDICATED A CHILD ABUSER.
- (3) THE DEPARIMENT OF HUMAN RESCURCES MAY NOT ENTER INTO THE CHILD ABUSE CENTRAL REGISTRY THE NAME OF ANY PERSON, UNLESS THAT PERSON HAS:
- (A) BEEN ADJUDICATED A CHILD ABUSER;
- (B) UNSUCCESSFULLY APPEALED THE ENTRY
  OF HIS NAME IN THE CHILDABUSE CENTRAL REGISTRY THROUGH
  PROCEDURES ESTABLISHED BY THE DEFARTMENT AND THIS ACT; OR
- TC NOTIFICATION BY THE DEPARTMENT OF HUMAN RESOURCES OF
