(A) (1) WITH RESPECT TO THE AFFILIATIONS OF OFFICERS AND DIRECTORS, A PUBLIC SERVICE COMPANY SHALL LIST IN ITS ANNUAL REPORT THE NAME, AND ADDRESS AND SOCIAL SECURITY NUMBER OF EACH OF THE PRINCIPAL OFFICERS AND EACH DIRECTOR, TRUSTEE, PARTNER OR PERSON EXERCISING SIMILAR FUNCTIONS, OF THE RESPONDENT AND PARENT TOGETHER WITH HIS TITLE AND POSITION WITH THE RESPONDENT AND WITH ANY PARENT, HOLDING COMPANY, PERSON, OR COMBINATION OF PERSONS, CONTROLLING THE RESPONDENT, AND WITH ANY SUBSIDIARY OF THE RESPONDENT AND ANY OTHER COMPANY, FIRM OR ORGANIZATION WHICH THE RESPONDENT CONTROLS.

(2) THE COMPANY SHALL LIST FOR EACH OF THE OFFICIALS NAMED IN PARAGRAPH (1), THE PRINCIPAL OCCUPATION OR BUSINESS AFFILIATION IF OTHER THAN LISTED IN THAT PARAGRAPH, AND ALL AFFILIATIONS WITH ANY OTHER BUSINESS OR FINANCIAL ORGANIZATIONS, FIRM, OR PARTNERSHIP DOING BUSINESS WITH THE RESPONDENT.
