- (b) Bight members of the Ccuncil shall be appointed for a term which will expire July 1, 1972; eight members shall be appointed for a term which will expire July 1, 1973; and nine members shall be appointed for a term which will expire July 1, 1974. All subsequent appointments shall be for terms of three years].
- (8) (4) THE--COUNCIL--CONSISTS--OF--25---MEMBERS APPOINTED-BY-THE-COVERNOR-
- (B) (1) THE COUNCIL SHALL CONSIST OF 30 MEMBERS APPOINTED BY THE GOVERNOF. COUNCIL MEMBERSHIP SHALL BE REDUCED TO 25 MEMBERS BY JULY 1, 1980. THIS REDUCTION SHALL BE ACCOMPLISHED BY REDUCING THE NUMBER OF REGULARLY SCHEDULED COUNCIL APPOINTMENTS (OF REAPPOINTMENTS) BY 2 ON JULY 1, 1978 AND 1979 AND BY 1 ON JULY 1, 1980.
- (2) THE MEMBERSHIP SHALL MAY INCLUDE INDIVIDUALS WHO:
- (I) FEPRESENT, AND ARE FAMILIAR WITH, THE VOCATIONAL NEEDS AND PROBLEMS OF MANAGEMENT IN THE STATE:

- (III) REPRESENT, AND ARE FAMILIAR WITH, THE VOCATIONAL NEEDS AND PROBLEMS OF AGRICULTURE IN THE STATE;
- (IV) REPRESENT STATE INDUSTRIAL AND ECONOMIC DEVELOPMENT AGENCIES;
- (V) REPRESENT CCMMUNITY AND JUNIOR COLLEGES;
- (VI) REPRESENT OTHER INSTITUTIONS OF HIGHER EDUCATION, AREA VOCATIONAL SCHOOLS, TECHNICAL INSTITUTES, AND POSTSECCNDARY AGENCIES OR INSTITUTIONS THAT PROVIDE PROGRAMS OF VOCATIONAL OR TECHNICAL EDUCATION AND TRAINING:
- (VII) HAVE SPECIAL KNOWLEDGE, EXPERIENCE, OR QUALIFICATIONS WITH RESPECT TO VCCATIONAL EDUCATION BUT ARE NOT INVOLVED IN THE ADMINISTRATION OF STATE OR LOCAL VOCATIONAL EDUCATION FROGRAMS:
- (VIII) REPRESENT, AND ARE FAMILIAR WITH, PUBLIC PROGRAMS OF VOCATIONAL EDUCATION IN COMPREHENSIVE SECONDARY SCHOOLS:
- (IX) REPRESENT, AND ARE FAMILIAR WITH, NCNPROFIT PRIVATE SCHOOLS;
