ORDINANCE, MAY PROVIDE FOR THE ESTABLISHMENT OF ROAD CONSTRUCTION DISTRICTS. TWO-THIRDS OF THE PROPERTY OWNERS ALONG THE ROAD ROUTE MAY PRESENT A WRITTEN PETITION TO THE COUNTY COMMISSIONERS REQUESTING THE CREATION OF A ROAD CONSTRUCTION DISTRICT AND REQUESTING A ROAD CONSTRUCTION OR REFAIR PROJECT. THE COUNTY COMMISSIONERS, UPON RECEIPT OF THE PETITION, MAY ESTABLISH THE DISTRICT AND DESIGNATE THE AREA INCLUDED WITHIN THE DISTRICT.

- (B) WHENEVER THE PLANS AND STECIFICATIONS FOR THE CONSTRUCTION OR REPAIR OF THE BOAD OR ROADS SHALL HAVE BEEN-GOMPLETED, THE COUNTY COMMISSIONERS SHALL SET UP A PUBLIC HEARING, SHALL NOTIFY THE OWNERS OF REAL PROPERTY IN THE PROPOSED DISTRICT OF THE TIME AND PLACE OF THE HEARING, AND SHALL ADVERTISE THE DATE BY MAILING A NOTICE OF THE HEARING ADDRESSED TO EACH CWNER AT HIS OR HER ADDRESS AS SHOWN ON THE ASSESSMENT RECORDS, AND BY GIVING NOTICE OF THE TIME AND PLACE OF THE HEARING IN TWO NEWSPAPERS OF GENERAL CIRCULATION IN THE COUNTY FOR TWO CONSECUTIVE WEEKS. AT SUCH HEARING, THE COMMISSIONERS SHALL DETERMINE THE SCOPE OF THE PROJECT AND SHALL ADVISE THE PROPERTY OWNERS OF THE APPROXIMATE COST OF THE PROJECT. THE COSTS SHALL BE PAID BACK TO THE COUNTY BY THE PROPERTY OWNERS WITHIN A PERIOD OF THE AND AT A RATE OF INTEREST TO BE DETERMINED BY THE COUNTY COMMISSIONERS IN ACCORDANCE WITH SUBSECTION (C)
- AFTER AFFORDING THE HEARING, THE COMMISSIONERS SHALL DETERMINE WHETHER TO PROCEED WITH THE CONSTRUCTION OR REPAIR. AND ESTIMATED INDIVIDUAL LEVIES. THE COMMISSIONERS SHALL DETERMINE WHETHER IT IS FEASIBLE TO TAKE THE ROAD INTO THE COUNTY ROAD SYSTEM AND TO UNDERTAKE THE ROAD CONSTRUCTION OR REPAIR FEOJECT; AND WHETHER UPON COMPLETION OF THE PROJECT THE ROAD CAN BE TAKEN INTO THE COUNTY ROAD SYSTEM IN ACCORDANCE WITH SUBSECTION (D). THE COMMISSIONERS SHALL ALSO DETERMINE WHETHER TO PROCEED WITH PLANS AND SPECIFICATIONS AND SHALL SET A DATE FOR FINAL HEARING WHICH DATE MAY ONLY BE CHANGED PROVIDED NOTICE IS GIVEN IN ACCORDANCE WITH THIS SUBSECTION.
- (C) AT THE FINAL HEARING, THE COMMISSIONERS SHALL ESTABLISH THE DISTRICT AND DESIGNATE THE AREA INCLUDED WITHIN THE DISTRICT. THE PROJECT SCCPE, COST ESTIMATE, AND ESTIMATED INDIVIDUAL LEVIES SHALL BE PROVIDED. THE ESTIMATED INDIVIDUAL LEVIES SHALL BE BASED ON THE ENEFITS ACCRUING TO EACH OF THE LCTS OF PARCELS OF LAND IN THE ROAD CONSTRUCTION DISTRICT TO THE EXTENT IT IS PENEFITTED BY THE SAID ROAD CONSTRUCTION. THE COSTS SHALL BE PAID BACK TO THE COUNTY BY THE PROPERTY OWNERS WITHIN A PERIOD OF TIME AND AT A RATE OF INTEREST TO BE DETERMINED BY THE COUNTY COMMISSIONERS. IF THE COUNTY COMMISSIONERS ARE EMPCWERED AND DIRECTED TO FIX AND LEVY A BENEFIT CHARGE UPON ALL REAL PROPERTY IN
