Notwithstanding [any other] THE provisions of [the law to the contrary] SECTION 7(A) AND (B), for the purpose of computing the shares of the State, local subdivisions, and students for the support of Chesapeake College and Garrett [County] Community College the [statutory base shall be \$2,365 per full-time equivalent student. The] State shall pay a 55 percent share, the student shall pay a 13 percent share, and the local subdivision shall pay a 32 percent share, with the State's share not to exceed the sum of [\$1,300] \$1,485 for each full-time equivalent student.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1977 contingent upon the taking effect of Chapter\_\_\_\_of the Acts of 1977 (H.B.\_\_\_or S.B.\_\_) which provides that Lottery Revenues collected in Fiscal year 1978 shall be placed in the General Fund for Fiscal Year 1978, and if Chapter\_\_\_does not become effective, this Act shall be null and void without the necessity of further action by the General Assembly.
